The Annual Sweet Grass Society Pow Wow has been a fixture in our community for nearly 50 years – the most recent event marked our 46th annual pow wow. The Pow Wow is sponsored by, funded, coordinated, and facilitated by MSU-Northern's indigenous student organization, the Sweet Grass Society. This student group raises nearly \$15,000 each year from our local community (businesses and private donors) to assist in hosting this event, which offers food trucks, prizes for competition and attendance, and professional facilitators (master of ceremonies, arena director, etc.). The Pow Wow brings tribal members from all over Montana and surrounding states to join in dancing, singing, and celebration and provides all within the Northern, Havre, and Hi-Line communities an incredible opportunity to experience and engage with Native American tradition and culture.

We partner with local tribal members to assist with the raising and to provide an educational presentation throughout the event to help participants understand the significance of the tradition and to highlight the tribes represented within our own student and campus community.

	In the fall of 2021, we began a tradition of inviting local musicians – Counting Coup of Billings, MT – to join us on campus for a concert and celebration of indigenous culture. Fall of 2022 saw the second annual event take place and we are in the process of booking and scheduling for the coming fall again. The event provides music, food, as well as an educational presentation on Native American dancing, singing, and drumming. Each of the past two years, this has included a discussion of Native American culture provided by our Chief Diversity Officer, Margarett Campbell, as well as dancing, singing, and drumming demonstrations from local performers, most of whom are members of our Northern and Hi-Line communities.

The primary goal of the MSUN NASNTI Project – the Little River Institute (LRI) – is to increase the on-time graduation rates of American Indian students at both the Bachelors and Associates levels. Its secondary goal is to increase fall-to-spring and fall-to-fall retention rates for American Indian students, including first-time, full-time students and those with continuing, transfer, and returning status. One of the most critical means by which we attempt to impact these metrics is through the offering of tutoring services within the LRI. We employ two full-time Pathfinders – professional tutors in writing and STEM –throughout the academic year.

Per data reported in the NASNTI Annual Performance Report for the grant year, October 1, 2021 through September 30, 2022, LRI tutors served 10% of the American Indian students eligible for the three semesters captured within the grant year (Fall 2021, Spring 2022, Fall 2022). Students participating in tutoring services at LRI also realized a 74% pass rate for the courses in which they were enrolled.
