Keith Johnson - Nominated by Montana State Council of Professional Fire Fighters
Keith is a paid fire fighter and training specialist with the Bozeman Fire Department. The
Bozeman Fire Department's mission is to minimize the loss of life, injury or property through
basic emergency medical care and fire rescue services. Fire Department staff provides fire code
inspections, code enforcement and fire safety survival education programs to the public. The
department provides a variety of services to the community including fire suppression,
emergency medical assistance, victim rescue, technician-level hazardous material response,
fire code enforcement, wild land fire response, trench, high angle, low angle, and confined
space rescue.

Stephen Hester – Nominated by Montana State Fire Chiefs Association

Steve Hester is currently the Assistant Fie Chief at Great Falls Fire and Rescue. Steve has thirty years of full-time fire protection experience, thirteen years of chief fire officer experience, and four years of Fire Service HazMat Training Specialist experience. Along with this experience, Steve is also a skilled public safety and education practitioner.
