## MINUTES OF BOARD OF REGENTS OF HIGHER EDUCATION MONTANA UNIVERSITY SYSTEM

January 6-7, 1980 Helena, Montana

The Board of Regents of Higher Education convened at 1:30 p.m. Monday, January 7, 1980, in the Conference Room of the office of the Commissioner of Higher Education, Helena, Montana. The meeting was called to order by Chairman James. Regents present: Lewy Evans, Ted James, Shelley Hopkins, Jeff Morrison, Mary Pace, Lola Hansen and John L. Peterson. Commissioner of Higher Education John A. Richardson was also present.

Chairman James called for additions or corrections to the minutes of the previous meeting. There being none, the minutes of the November 2, 1979 meeting were ordered approved by the Chair.

Chairman James stated that with approval, the agenda would be revised to go through the blue book prior to the review of the Butte Nursing program.

Mary Pace reported that the Curriculum Committee did not discuss the Community-University Experimental Series (CUES) because the committee was informed that a new proposal had been submitted which does not require Regental action.

Mary Pace moved that the gubernatorial appointment of V. Eugene Cetrone, to the Local Executive Board at Eastern Montana College be confirmed. The motion carried.

Mary Pace moved to approve the appointment of Dr. Terrance Cypher to the Western Montana College Faculty Service Committee as the Regents' appointee. Motion carried.

Commissioner Richardson reported that the Legislative Finance Committee will meet on February 2, 1980 to hear testimony on the preliminary paper developed by its staff relative to funding of the University System.

Commissioner Richardson read the following statement:

Louis Forsell is retiring after nearly twenty years of service to the State of Montana, the last three-and-a half of which have been as Chief Legal Counsel to the Board of Regents of Higher Education.

The Board of Regents acknowledges and expresses its gratitude and appreciation to Louis Forsell for his contributions to the Montana University System and to the State of Montana.

Louis Forsell is a native Montanan, born and reared in Butte, USA, as he is fond of telling newcomers to the state of the proper address for Montana's most famous city. He initially attended the Montana School of Mines and later the University of Montana where he earned a B.A. and J.D. degree. He also spent a year at the University of Wisconsin where he became familiar with the old Norwegian story of the Devil sitting between two lawyers crying, "Virtue in the middle"! He was awarded the Justin Miller prize for legal writing and had the next to highest scholastic standing in his law school class.

Louie entered the military service of the U.S. in September 1942 where he served in military intelligence until 1945.

He served in several capacities in the public service of the State of Montana: interviewer and office manager for the Montana State Employment Service; Assistant to several attorneys general; chief of the State Auditor's legal division and finally as Chief Legal Counsel to the Board of Regents of Higher Education. Interspersed throughout his many years of public state service are several years of private legal practice and several as a nationwide insurance examiner.

The greater portion of his professional life has been centered in public law where an extensive background in statutory construction, administrative law and procedure and federal and state civil and appelate procedure have been requisites. Since joining the Montana University System a staunch defense of the constitutional autonomy of the Board of Regents has required the agility and facility of his keen legal faculties. He has taught us all that the constitutional vesting of the Board of Regents with "full power, responsibility, and authority to supervise, coordinate, manage and control the Montana University System . . . " is more than a hollow shell.

His legal knowledge is matched by a warm compassion for his fellowman where his philosophy of one day at a time is well known to his counselees. A vast knowledge of the history of the State of Montana and a particular knowledge and under-

standing of the customs, traditions and concerns of its native Americans has been an ever present asset to the State.

Among his colleagues and friends he is respected for being well-read and versed in many of life's disciplines, particularly literature and the arts.

A fitting tribute to such a person can be found in Thomas Huxley's A Liberal Education:

"For every man the world is as fresh as it was at the first day, and as full of untold novelties for him who has the eyes to see them."

Chairman James requested that the statement be spread on the minutes.

In the review of the Butte nursing program, Dr. Tietz discussed MSU's position and explained the criteria used in making the decision to discontinue the program in Butte. Testimony in support of the program was presented by Butte-Silver Bow interested persons, including representatives of the medical community, students currently in the program, and Butte area legislators. In response to questions from Jack Peterson, Dr. Tietz explained the problems involved in setting budgets that will be implemented one, two or even three years in the future. Notification requirements to faculty under contract complicates the procedures when management decisions dictate the reallocation of internal resources or the shifting of program emphasis.

Jack Peterson reviewed the information brought to the Board which led to the expansion of the clinical nursing program in Missoula, and stated that when that information was supplied there were no data produced which would indicate that any existing campus would be cut. The Board responded to what it believed to be a need for additional clinical nursing spots. Mr. Peterson concluded that he believed in fairness to the policy set previously by the Board and to the Butte medical community, the nursing program in Butte should be continued.

Mr. James agreed with Mr. Peterson and stated he felt the program in Butte must be continued for the good of the students and the community, and if you will, from a political standpoint. All the units are underfunded and Mr. James said he found this difficult to understand when the state has the largest surplus in its history.

Further discussion brought out that of the 36 students in the program, 33 are from locations other than Butte and that space is available for the students at the other campuses. Mr. Morrison said he believed that keeping the program open was a public service decision, not one based on what is best for higher education.

Mary Pace said she felt the real issue is not that of continuing or discontinuing the Butte nursing program, but whether the Board is assuming the job it hires presidents to do. She stated that if the Board of Regents bows to outside political pressure and interferes with an internal management decision made by the president of a unit, the Board is seriously undermining the authority of the presidents to manage the internal affairs of their college or university.

Jack Peterson then made the following motion: MSU be directed to maintain the status quo of the clinical nursing program at all four off-campus sites, Billings, Great Falls, Butte and Missoula, for the balance of the biennium.

Commissioner Richardson stated he agreed with Chairman James that the University System needs additional funding, and that the decision on this issue can be looked at from four different perspectives. As a policy issue, the Board of Regents can make the decision but in this instance to do so would, in the Commissioner's opinion, subvert the authority of a president to manage the curricular and administrative affairs of his institution. As an educational issue, the decision to close the Butte extended campus was a sound one based on the enrollment decline in nursing, increased enrollment in other disciplines, the number of clinical spots and the number of nurses in Montana. From a medical perspective, the claims that the proposed action will harm the provision of medical services in Butte are probably true, but the question must be asked if the provision of such services is a primary responsibility of the Montana University System. In the Commissioner's view it is not.

From a political perspective, the Butte delegation has historically been a friend of the Montana University System and there is no desire or intent to harm that relationship.

Commissioner Richardson concluded that the educational and administrative considerations outweigh the other two in his mind, and he therefore supports the position taken by the administration of Montana State University.

The question was called on Jack Peterson's motion. Regents Hopkins, Morrison and Peterson voted yes; Regents Pace, Hansen and Evans voted no, resulting in a tie vote. The Chair voted yes. The motion carried.

The meeting adjourned.
