The Montana Bureau of Mines and Geology (MBMG) operates the 42-station Montana Regional Seismograph Network. The Confederated Salish and Kootenai Tribes' (CSKT) Safety of Dams Program operates seven of these seismograph stations along with computers used to record and analyze the collected seismic data. The tribal stations were installed in 1995 to monitor seismic activity around the high-hazard dams on the Flathead Reservation. Following significant local earthquakes (magnitude 3.5 or larger), tribal authorities are provided the time, location, and magnitude information. Using this information, tribal authorities determine which dams may require post-earthquake inspections. CSKT purchased the original seismic monitoring equipment and covers maintenance and operational expenses. Through an annual cooperative agreement, the CSKT provides about \$25,000 to MBMG for seismic data analysis, reporting and archival, and equipment repair and operation. The Montana earthquake catalog compiled using these data is included updates of the US Geological Survey's National Seismic Hazard Map, upon which the National Building Code is based.

Montana Tech's Graduate School participates in and contributes to efforts to increase the participation and graduation of American Indian students with master's and doctoral degrees. These efforts include the Sloan Indigenous Graduate Partnership (SIGP) and the PNW COSMOS (Pacific Northwest Circle of Success Mentoring Opportunities in STEM) Alliance for Graduate Education. SIGP provides financial support, mentoring, and networking to American Indian students in STEM (science, technology, engineering, or math) on-campus, research-based master's and PhD programs. Montana Tech, MSU, and UM participate, along with Purdue, University of Arizona, University of Alaska (Anchorage and Fairbanks), and the SUNY College of Environmental Science & Forestry. The National Science Foundation-funded PNW COSMOS involves Tech, UM, MSU, Washington State University, Salish Kootenai College, Heritage University (Washington), and Northwest Indian College and it developed an indigenous mentoring program that has been adopted, adapted, and institutionalized at Montana Tech during the past Fiscal Year.

Montana Tech has been a partner in SIGP for over 10 years, and typically enrolls one to four students. Its purpose is to increase the participation of American Indians and Alaska Natives in

STEM graduate study through welcoming and supportive campus environments that cater to the needs of indigenous students and their families. Over 80% of the students complete their degrees, and we actively invite and host visits by prospective students (see photo). PNW COSMOS has provided face-to-face and video-conferenced live indigenous mentoring program (IMP) workshops for Tech faculty and staff and it has assembled resources, now available through Moodle, for self-paced participation by any faculty or staff member into the future. The IMP was developed and guided by American Indians.
