- Men Stopping Rape: 10 male students leaders offer 15-20 trainings a year to campus groups, residence halls, etc. This group held a *Rock Against Rape* concert last spring.
- Fraternity/Sorority Violence Prevention Institute: student-to-student training for 100+ students in the fraternities and sororities.

- Fraternity/Sorority Violence Prevention Officer: A new requirement that every fraternity/sorority will have a trained student leader for violence prevention. These officers will provide individual training for other students, plus provide oversight during events with alcohol.
- Violence Prevention Programs for Students (Called *Not in our House*): New student-to-student seminar series offering bi-monthly programs for students by students.
- Required training for all student-athletes on sexual violence.
- Red-Zone Rally – Welcome back to school rally on campus during the first week of school; 300 students attended.
- 40 student advocates trained each year by the VOICE Center; these students provide a 24-hour crisis support and response for student victims.
- Tons of give-a-ways from the new Office of Institutional Equity; new on-line training for employees and a new on-line reporting structure.
