Chair Lozar welcomed all attendees. He noted the purpose of today's agenda is to allow for a comprehensive discussion of the MUS Healthy Fall 2020 recommendations and planning guidelines that will elevate our consideration to the point of formal Board action. He noted that the planning areas offer areas offer guidance to campuses on everything from delivering quality instruction to campus safety and security. In addition, Deputy Commissioner Tessman will discuss a set of overall guidelines offered by the Task Force – ranging from travel policy to communications coordination and accessibility issues. He will also outline the process and timeline the Task Force used to develop its guidelines and the manner in which campus experts and public health experts were consulted along the way.
