#### **Introduction**

#### Montana State Approving Agency (SAA)

- Assigned to Montana Department of Labor & Industry (DLI)
- Contracted by U.S. Department of Veterans Affairs (VA)
- General Duties and Responsibilities:
  - State approving authority for all schools and training establishments with GI Bill<sub>®</sub> approved education and training programs
  - $\,\circ\,$  Oversight and supervision
  - Protect and safeguard GI Bill benefits
  - $\circ\,$  Outreach and liaison
  - Collaborate with School Certifying Officials (SCOs), VA, employers, and other state government agencies



## **GI Bill Overview**

- Traditionally, military veterans receive 36 months of GI Bill benefits
- GI Bill benefits can be used for:
  - Institutions of Higher Learning (IHLs)
  - Non-College Degree (NCD) schools
  - Apprenticeships/On-the-Job (OJT) training programs
  - vocational Flight Training
- More than 50% of individuals with GI Bill use their benefits at an IHL
- GI Bill covers tuition and fees at all public IHLs
- GI Bill students also receive a book stipend and monthly allowance

\*New legislation requires all GI Bill students to be charged in-state tuition, with a few exceptions. \*\*Only fees that are mandatory for all students are authorized to be paid by the GI Bill. \*\*\*Amount of benefits awarded to veteran and eligibility benefit percentage are determined by length of military service.

Approximately 30% of GI Bill students are paid directly by VA and then responsible for paying the institution. ### SAA & OCHE

- Intersecting policies, procedures, and objectives
- State level collaboration and information sharing
- Shared common goal of helping student veterans and veteran representatives at MUS schools
- Monthly coalition meetings SAA, OCHE, & IHLs



### SAA & School Certifying Officials (SCOs)

- SCOs are the liaisons between GI Bill students and VA
- Per VA policy, IHLs approved for the GI Bill are required to conduct reapprovals with the SAA at least every two years
- Re-Approvals are mandated to ensure any new requirements found in applicable laws and policies are being incorporated in catalog and/or implemented into institutional policies
- Re-Approval process also includes updating the list of programs offered by an institution (degree & certificate)

#### 20 years of serving Post 9/11 Veterans in the MUS.

- Brand new benefit available to veterans and dependents in Chapter 33 Post 9/11 GI Bill <sup>®</sup>
- Life in the military could not continue: deployments, injuries, burnout.
- Student veterans seeking accommodations due to service-connected injuries.
- Serving large numbers of non-traditional aged students with families and complex finances.
- Navigating retention issues.

#### Serving student veterans today in Montana.

- Fewer deployments, fewer combat veterans, fewer "visible scars of war".
- Demand for mental health resources continues to climb.
- Transition anxiety.
- Single enlistments, younger student veterans.

- More National Guard students: MUS tuition waiver.
