## Minutes Montana Board of Regents January 8, 2025

**Wednesday, January 8, 2025**

Meeting convened at 9:03 am

Ex officio members present included Commissioner of Higher Education Clayton Christian, Governor Greg Gianforte, represented by Dylan Klapmeier, and Superintendent Susie Hedalen.

Comments by Chair Buchanan | 00:01:06

Chair Buchanan congratulated the MUS fall graduates. He said the 69<sup>th</sup> Legislative Session has convened and reviewed the morning's agenda. He congratulated the emeriti faculty who are on the agenda.

Commissioner's Report | 00:03:38

Commissioner Christian thanked everyone for their attendance and congratulated the MSU football team for representing Montana. He gave a legislative update and said the MUS is working closely with the Governor's Office and the Legislature to meet the needs of the MUS. He thanked the Governor for making higher education a priority. He said that OCHE staff are tracking the bills that have the potential to impact the MUS.

Deputy Director Hollenbaugh said the MUS's top three priority bills for the session (HB 2, HB 5, and HB 13) have been scheduled for their initial hearings. He reviewed HB 13, the proposed State Pay Plan, discussed Senate rule changes, and provided some upcoming hearing dates. He said that legislative updates will be provided every Friday afternoon. ## Executive Session


