Minutes Montana Board of Regents May 20, 2026

Thursday, May 20, 2026

Meeting convened at 8:31 am

Regents Present: Todd Buchanan, Chair, Loren Bough, Jeff Southworth, Dean Folkvord, Heather Hoyer, Daniel Spoon, and Carter Jasper, Ex officio members present included Commissioner of Higher Education Clayton Christian and Superintendent Susie Hedalen represented by Deputy Superintendent, Craig Barringer. Ex officio member Governor Greg Gianforte was excused.

Comments by Chair Buchanan | 00:01:07

Chair Buchanan thanked everyone for their attendance and acknowledged the importance of the Board's connection to faculty with its regular breakfast meetings with MUSFAR. He welcomed faculty representative, Grant Olson from MSUN, and tribal representative President Cory Sangrey, Stone Child College. He congratulated the spring graduates across the MUS. He thanked Chancellor Kegel for his leadership at MSUN and congratulated him on his retirement. Chair Buchanan discussed leadership transitions in the MUS over the past few years and changes to the leadership recruitment process. He said he is excited for the new leadership and the expertise they bring to the MUS. He concluded with a review of the agenda.

Chancellor Greg Kegel welcomed everyone to MSUN and thanked faculty and staff for preparing the campus for the meeting. He shared what an honor it has been serving at MSUN over the past 44 years and thanked the regents, OCHE staff, and staff across the MUS for their continued support. He discussed how MSUN attracts and retains students, reviewed the strategic advancement team and charge groups that were created, and highlighted some of the programs, projects, and enhancements that have been implemented on campus. He shared what MSUN is doing to strengthen partnerships to move the institution forward. Chancellor Kegel discussed MSUN's strategies for keeping costs down for students and investments made in enhancing the student experience. He concluded with a video highlighting innovation and research at MSUN.

Commissioner Christian welcomed and thanked everyone for attending the meeting and thanked Chancellor Kegel and his staff for hosting the meeting. He acknowledged Chancellor Kegel for his dedication to MSUN over his 44-year career and congratulated him on his retirement. He congratulated the spring graduates, expressed his gratitude for having participated in the University of Montana's commencement ceremonies, and thanked faculty and staff across the MUS for their dedication to student success. Commissioner Christian said he had the privilege of participating in a Blackfeet Pipe Ceremony and commented on what a moving experience it was. He thanked the Tribal Colleges for their continued partnership with the MUS. He said the MUS is actively preparing for the 70th Legislative Session and the opportunity to advance the 6-mill levy, noting its importance to the MUS.

Deputy Superintendent of Public Instruction Craig Barringer congratulated Chancellor Kegel on his retirement and thanked him for his years of service at MSUN. Commissioner Christian presented the request per Board Policy to authorize the naming of the Auxiliary Gyms in the Adams center after Steve and Shirley Nelson.

Director of Facilities, Dan Stevenson, presented the request to increase spending authority to \$6M for UM's McGill Hall construction project to house the Montana Center for Work Physiology and Exercise Metabolism (WPEM). The 68th Legislature provided \$3M authority-only for the planning, design, and construction of this addition with subsequent BOR authorization. The 69th Legislature provided an additional \$3M in authority-only for a total of \$6M. Project design is in progress and



anticipated to be bid in summer 2026. This project will be paid for using Facilities and Administrative (F&A) cost recoveries from the federal grants received by WPEM.

Deputy Commissioner for Budget and Planning, Tyler Trevor, said fees are typically addressed during the May meeting after the legislative session, but Board policy provides an exception for associated students to come forward with fee requests.

UM Vice President of Operations and Finance, Paul Lasiter, presented the request for a \$10 increase in the standard ASUM fee and an \$18 increase in the transportation fee per semester for each academic year.

ASUM President, Buddy Wilson, described in detail how revenue from these fees is used and the level of student support among the students for the increases. Discussion followed.

Director Stevenson presented this request to authorize Montana State University to spend up to \$3.5M to begin construction on housing improvements. This request is for the first phase of construction to prepare the site for new housing including removal of dilapidated housing, installation of new and expanded utility infrastructure and associated work. The estimated total for new housing construction is up to \$50M. The work will be paid for using auxiliary revenues.

Director of Budget and Administration, Margaret Wallace, presented the tuition and fee increase requests for Flathead Valley Community College and Dawson Community College. She noted that community colleges operate under a dual-governance structure, with local Boards of Trustees providing management oversight and the Board of Regents providing supervision and coordination under BOR Policy. Both proposals were approved by their local Boards of Trustees and were reviewed in the context of current higher education inflationary and operating cost pressures. FVCC requested a 3% tuition increase and 5% mandatory fee increase, for an overall increase of approximately 3.5%, while DCC requested a 5% tuition increase and 8% mandatory fee increase, for an overall increase of 6.5% for in-district students. Discussion followed.

Interim Deputy Commissioner for Academic, Research & Student Affairs, Joe Thiel, said this proposed policy change arises from the work of the MUS Academic Process Task Force to establish an ongoing performance-based review of academic programs across the MUS that compliments the seven-year cycle review that campuses undergo. Discussion followed.

- d. MT 10/Campus Innovation Projects

OCHE Director of Student Affairs, Crystine Miller, provided an update on MT10 and Institutional Innovation projects funded through one-time-only legislative funding. MUS institutions continue to deliver MT10 with new cohorts at 9 MUS campuses this fall including MSU, which newly launched MT10. Director Miller said campuses have also launched institutional innovation projects that aim to enhance student success by bringing innovative, technology-driven solutions to reducing operational and process frictions in the student experience and academic journeys. She said



these projects are intended to enhance on-time graduation and reduce time-to-degree. Discussion followed.

e. Math Pathways Report

Associate Professor & incoming Missoula College Interim Dean, Lauren Fern, and Director Miller updated the Board on efforts to support students in gateway (first required college-level) math and writing course completion. They said that existing math pathways had been revised and refined to address changes in math skill needs within meta-majors, develop clear pathway for trades fields, and support credit mobility among dual enrollment, transfer, and cross-registration student populations.

f. e-Learning Report and Panel

Interim Deputy Commissioner Thiel gave an overview of the panel and what they do to help distance learning students. He introduced Eric Vorkoeper, Chair of the Advisory Council, and Vice Chair, Samuel Giordanengo.

Chair Vorkoeper said the last e-learning academic report was generated in 2022 and the new report shows the progress that has been made over the past three years. They discussed the growth of online education, out of state online enrollment trends, how a wider range of students are served with distance education, how the MUS distance education program works, investment updates, and future initiatives. Discussion followed.

g. Student Leadership Panel

Student Panelists Johathan Wamsley, Kiaya Doney, and Danielle Cahill, shared their journeys leading to college, their experiences along the way as students, and the degrees they are pursuing. Discussion followed.

Director DeWolf King presented the proposed changes to the Degree Requirements Checklist policy. She said these proposed changes, which will likely be voted on at the July Board of Regents meeting, will bring this policy in line with changes made in July 2025. In October 2023, the U.S. Department of Education announced that, effective July 1, 2024, institutions participating in Title IV financial aid programs are prohibited from withholding student transcripts in certain circumstances. In July 2025, the Montana Board of Regents approved revisions to Policy 940.21 to comply with these federal requirements.

b. Transfer Update

Director DeWolf King provided a transfer update to the Board of Regents. She discussed transfer data in the system, work accomplished this year by the Transfer Advisory Council, and plans for 2026-27 academic year transfer work.

c. Class 8 Licensure

Director of American Indian/Minority Achievement and K-12 Partnerships, Dr. Angela McLean, summarized the upcoming Board of Public Education changes to the Class 8 educator license. McLean said the BPE had drafted a new rule creating a licensure exception for college faculty who teach dual enrollment classes. She added that the BPE planned to repeal the existing Class 8 license and that this process would likely conclude before the beginning of the 2026-27 academic year. McLean said that these changes were designed to grow access to dual enrollment courses.

d. Workforce Pell | Attachment #1.

Interim Deputy Commissioner Thiel presented on Workforce Pell, including key facts, a federal timeline, approval process for programs, program eligibility criteria, and accountability measures. He said it is expected to take some time before there are a substantial number of programs gaining eligibility through this process. He said the Lumina Foundation has provided the MUS with support to improve infrastructure for non-credit and short-term training.

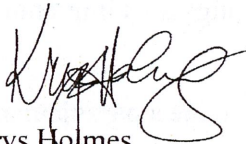

Our small towns across Montana struggle to find and keep knowledgeable, energetic leaders who have community-building, financial, management, and creative expertise. Many high-school graduates with those broad interests either leave the state or settle in at home and make do.

Our rural youth need the combination of skills that the Community Arts Production degree is designed to develop: how to operate a community-based nonprofit business; community organizing and collaboration; working with artists and the arts to achieve community goals in youth engagement, public health, downtown economic vitality, and human well-being; producing successful public events; marketing and business management; grant writing; budgeting; and how to work with local business leaders, government, and funders. Young Montanans graduating with this degree will be equipped to take on the challenges of 21st-century life in rural areas with creativity, skill, and support.

The Community Arts Production degree is at heart a workforce development program. From where I sit, I believe the program will be sustainable into the future, and will attract traditional and non-traditional students from across the state. As jobs and communities evolve, and as rural Montana continues to lose educated youth to jobs elsewhere, this program meets a growing need across northeast Montana to provide the skills and expertise to cultivate a new generation of rural leaders.

I commend the Commission for supporting this innovative program. I believe rural schools across the country will look to it as a model, and I am excited to see it come to fruition.
