Commendations:

- The Chemistry Program offers a solid chemistry curriculum with state-of-the-art experiences, equipment and training.
- The Chemistry Program faculty strive to educate students in person to meet the employment needs of local industries.
- The Chemistry Program faculty are working hard to provide students with curriculum that addresses gaps in the student's deficiencies in applied mathematics.

• The department works hard to provide student in Eastern Montana with positive and vibrant STEM experiences through the *Atomic Circus* and the Science Expo.

Recommendations:

- Continue to develop a robust, regular, course-specific assessment plan that monitors *your* student population. The ACS exams are good assessments to make comparisons of student performance based on national data, but when a student body does not reflect the demographics, resourcing, and experiences of the nation, assessment that is specific to the student population is needed to monitor how curricular and classroom methods impact learning. As you carry this assessment out, consider abandoning the ACS recommendations and focus a curriculum around skill building for targeted industries or research programs and student-driven elective course offerings.
- The department should create specific plans for addressing the DFW rates in Chemistry. This may not be just the Math requirement.

Overall, this is a strong undergraduate program that also supports our Biology and Health and Human Performance program and the recommendations outlined above will work to further strengthen it.

Rationale or justification for the decision based on the program review process established at the campus. Include graduation numbers and student majors for each of the last seven (7) years for every program under review.

The Department of Business Administration completed its program review concerning the Business Administration - Marketing option and the Marketing minor. The review revealed several strengths of the program, First, the rotation of courses is carefully designed to be delivered by a limited number of faculty. Second, the curriculum is designed to emphasize experiential learning. Third, assessment data for the option, which are regularly gathered and analyzed, generally demonstrate satisfactory and better-than-satisfactory results. Fourth, the faculty are highly supportive of the students' extracurricular activities, especially the Marketing Club and the American Indigenous Business Leaders Club. Fifth, the faculty employ EAB Navigate to assist in retention, a software that allows them to issue student alerts. Sixth, the cohort retention rates in Marketing are on par with the MSUB institutional rates for cohort retention. And last, the faculty are current in their field as evidence by their recent Association to Advance Collegiate Schools of Business (AACSB) evaluation which determined both faculty members as meeting the criteria as "Scholarly Academics" (SA).

Recommendations for program improvement were as follows. First, with attention to the enrollment trends and to the emerging societal impacts mission of the department, the faculty should develop specific <u>curricular innovations</u> that will make the Marketing option attractive to a broad audience of students. Second, the faculty should develop a <u>recruiting plan specific to the Marketing option</u>, especially for use in local high schools and/or with social media dimensions. Third, the faculty should <u>assist the dean in identifying an adjunct faculty</u> that can help reduce overload demands, thus allowing faculty to develop assessment mechanism for the minor, to bring Al into focus as a fundamental dynamic in the marketing profession, to offer experimental courses as special topics, and to improve available time for research and scholarly activities so that the faculty will continue to hold SA status. Lasty, the faculty should <u>adjust assessment practices by reducing the number of learning outcomes</u> being assessed.

The History Department is comprised of engaged and talented faculty members who work with great dedication to maintain and offer a strong academic pathway for their students. According to the data in this report, enrollment in the History major has fluctuated, with a notable decline in the Covid period followed by a steady recovery. The minor followed a similar pattern on a smaller scale, arriving at a total of 12 students enrolled in the History minor in 2023-24. I assume, since the History BA and History BA Teaching Option are the two primary options under the larger heading of History, that students sometimes migrate from one to the other major and are often enrolled in the same courses.

Regular internships represent a strategic, positive element in this program and offer students valuable experiential learning. The intention to expand the number of internships is a strong feature of the Department's future planning and is likely to provide pathways to careers.

The Department, under the leadership of Chair Arendt, has done an excellent job of creating rotations and course offerings so that students can finish on time and enrollments in any given course remain viable.

The Department has undertaken specific strategies to attract majors, including an Annual Edgerton History Lecture, outreach to potential majors, and community building spaces and activities for current majors and minors. Regularly inviting students to a regional History Conference is a particularly strong practice alongside other Experiential Learning opportunities.

This program is aligned with the Montana Professional Educator Preparation Program Standards (PEPPS) and is accredited by the State of Montana and the national Council for Accreditation of Educator Preparation (CAEP). The administration and faculty have a strong commitment to providing high quality teacher education to shape the next generation of educators in Montana schools. They have a) designed the program to be accessible to provisionally licensed teacher candidates; b) undertaken substantial work on improving candidate assessments to be more reliable and valid; and c) articulated ideas for adapting to the changing landscapes in teacher education that contribute to the declining enrollment. In addition, the program has developed a clear five-year plan for recruitment and retention and has created an Advisory Board to address a range of areas and help to develop strategies in these areas to support future innovation and growth. There is a positive and pro-active approach to the program's future, with an openness to innovation.
