






State Appropriations can be split into two periods, Flat Funding Era vs Tuition Freeze Era

#### (2023 constant dollars)




The U-system receives fewer state approps today than it did in 1992 (inflationary adj)


#### FY24 marks the first year funding per resident student surpassed the 1992 high mark




State % Share has dropped from 76% to 44% over past 30 years

(does not include program tuition and general fund fee revenue)




#### Tuition revenue projected to be up 7%:

### **MUS Current Unrestricted Revenue - Operating Budget**




Current Unrestricted Revenue budgeted to increase by \$31M (6%) -- does not include transfers or OTO

- 1) State Support up \$14M (6%) \*\*pay plan/present law\*\*
- 2) Tuition Revenue up \$18M (7%) \*\*tuition increases + enrollment growth\*\*
- 3) Transfers/Other down \$3M \*\*scholarships, deferred maintenance, BOR reserve\*\*




Tuition/Fees and MUS Expenditures have mirrored the growth of inflation.

#### Compounded Annual Growth Rate, FY14 - FY24




#### Tuition freezes accelerated State Approps and slowed the growth of tuition/fees.

#### In real/constant dollars, MUS total expenditures drop by -1.6% over the past 10 years.






#### Growth of Key Budget Drivers

10-year, Cumulative % Change






#### Higher Education expenditures nationwide increased at almost twice the pace as the MUS 14




## Net Tuition Revenue per Student FTE, FY22 🍐 SHEED





## Student Enrollment (national perspective)

Historically, FTE enrollment <sup>1</sup> has increased in each decade. Starting in 2009, enrollment increased rapidly during and immediately following the Great Recession, having peaked at 11.65 million students in 2011. Now, the most recent decade has seen a reverse in the trend:

- 6.85 million in 1980.
- 7.77 million in 1990.
- 8.38 million in 2000.
- 11.38 million in 2010.
- 10.91 million in 2020.
- 10.31 million in 2022.



- There were 10.3 million FTE enrolled students in 2022. Net FTE enrollment declined 2.5% in 2022, a loss of 266,338 FTE students, the second largest FTE decline on record after last year.
- 2022 marks the 11th straight year of enrollment declines following substantial enrollment increases during the Great Recession.
- Altogether, FTE enrollment has declined 11.6% from its peak in 2011, and remains just 0.4% above 2008 levels.
- Enrollment declined in 41 states between 2021 and 2022

#### Enrollment in the MUS has increased slightly each year since 2021





#### **Major Budget Drivers**

- Pay Plan = \$17.5M and Present Law = \$8M
- Enrollment (Res/Non-res/WUE); projected increase
- Resident/Non-Res tuition increases; increasing tuition revenue
- Enrollment management and financial aid
- Staffing demands




## Keep it Simple!





### **Present Law Increases & Pay Plan**

- Pay Plan (4% or \$1.50 per hour, whichever is greater)
  = \$8.7M state, \$8.7M tuition, total = \$17.5M
- Present Law Adjustment
  - Higher Ed Specific Costs (IT, library, safety, compliance, rent, contracts, maintenance)
  - Other Costs (utilities, compliance/safety)
  - Other Personnel Costs (faculty merit/market, leave payout, retention)
  - = \$4M state, \$4M tuition, total =\$8M

Policy 940.13: The MUS must ensure that the average net tuition revenue per non-resident student (not including WUE students) exceeds the average net tuition revenue plus state appropriations per resident student. In other words, net educational revenues per student FTE must be greater for the non-resident student population than the resident student population.

Waivers per student: 12% budgeted increase, growth of \$260 per student FTE
 Net tuition revenue per student continues to increase, +6% increase FY23 over FY22
 Average Net Revenue per FTE Benchmark: Yes, meets required levels
