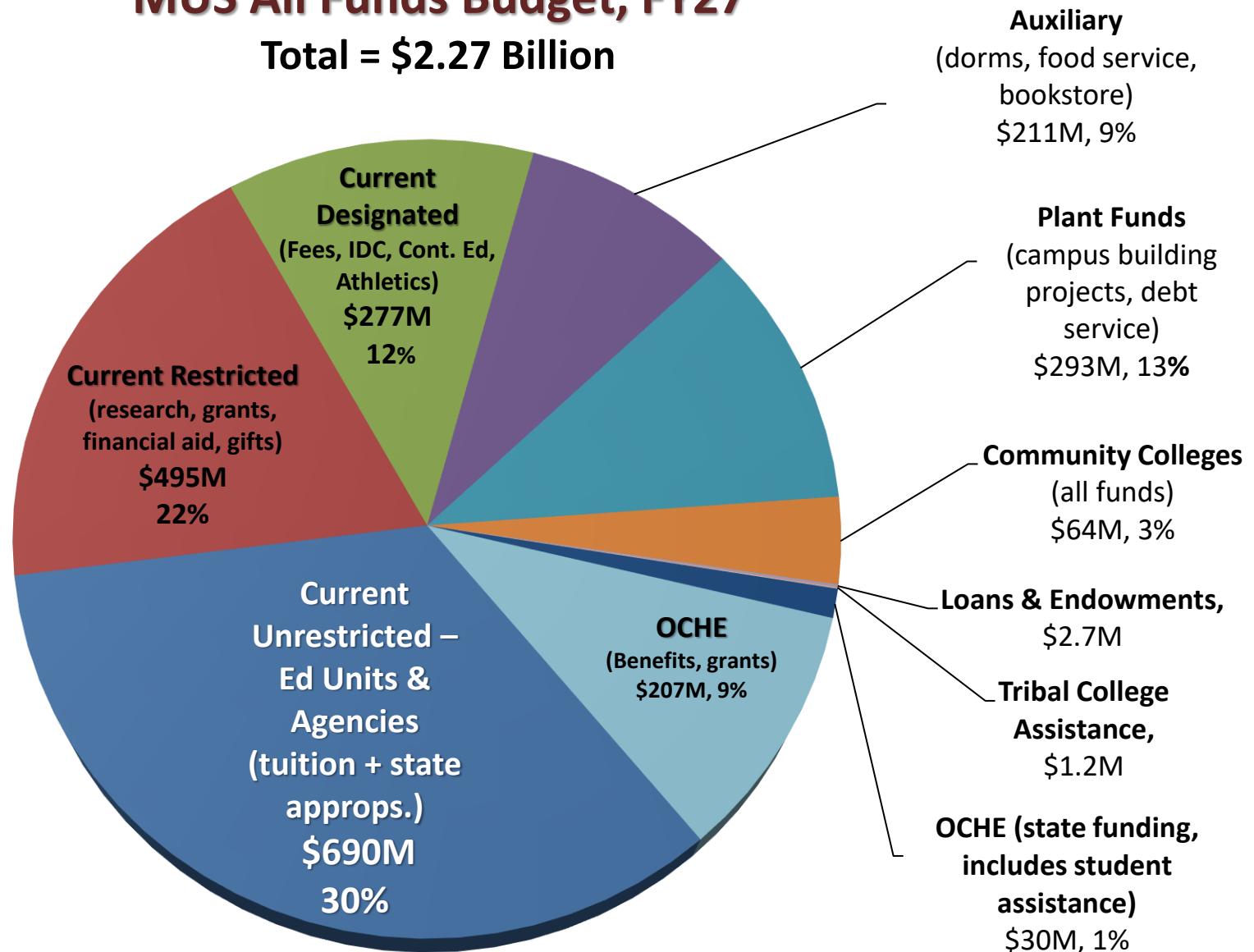

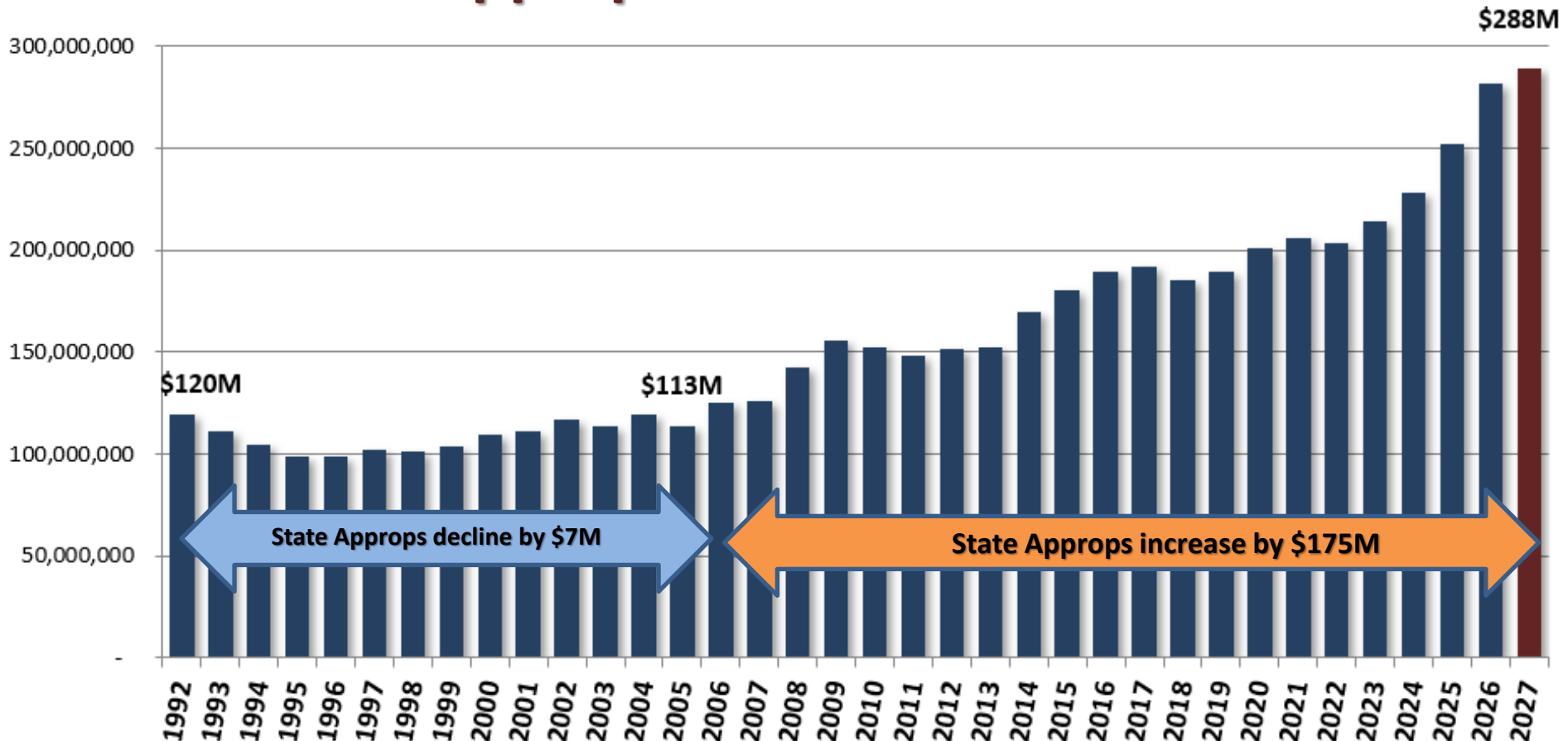

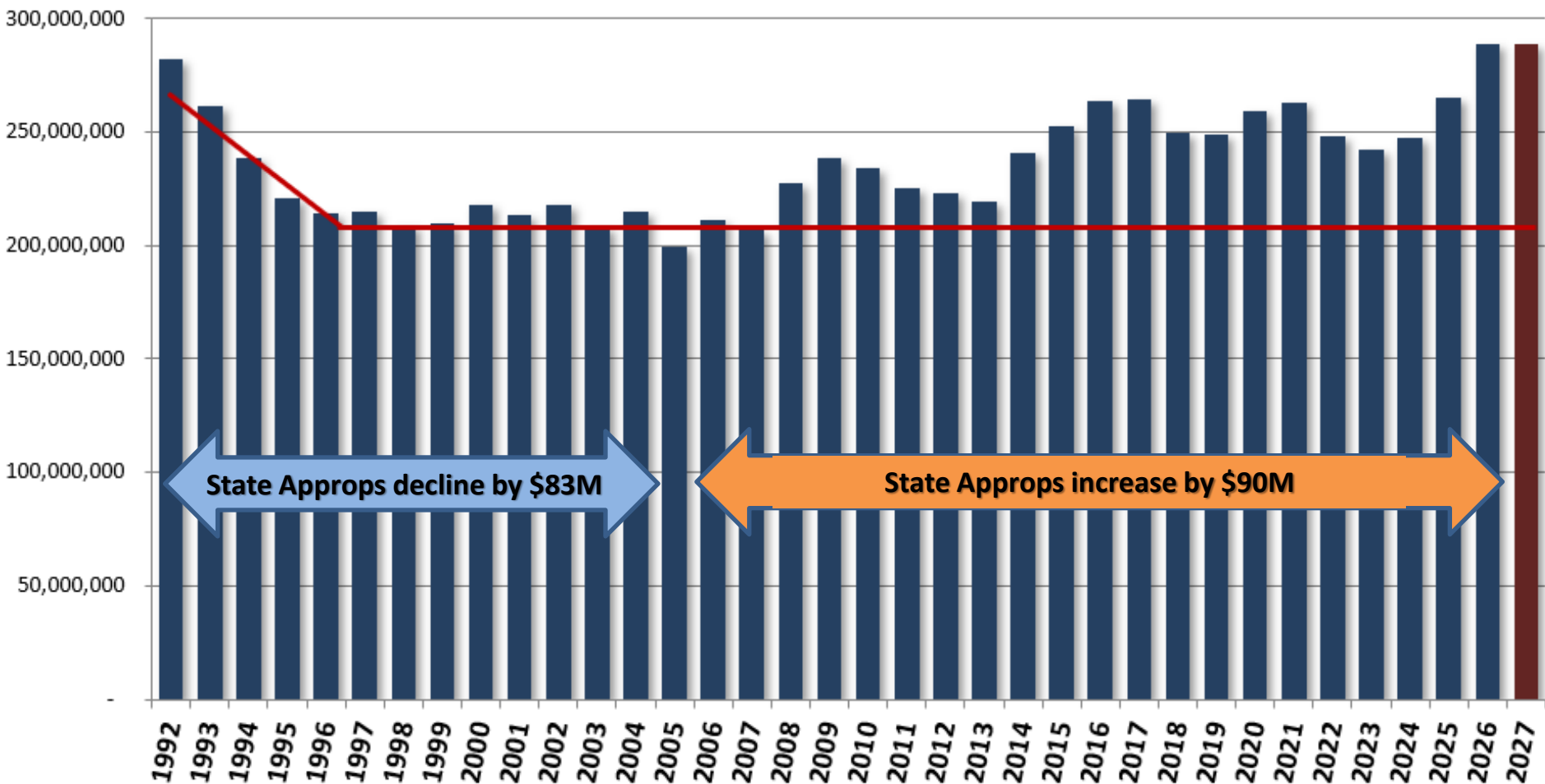

1992 – 2005 flat/defunded era; 2006-2026 state investment era

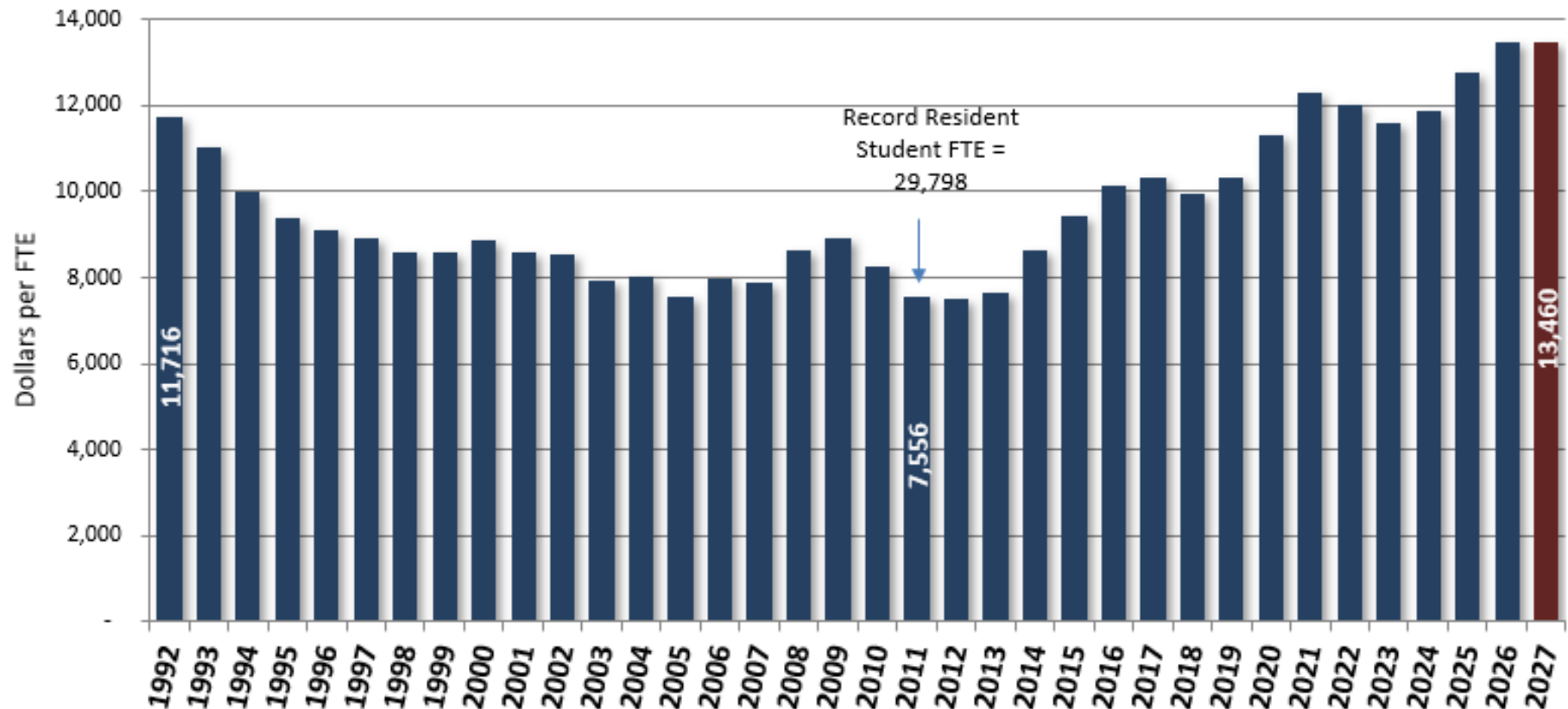
State Appropriations -- MUS Ed. Units (2026 constant dollars)

State Appropriations per Resident Student FTE -- Ed Units Only (2026 constant dollars)

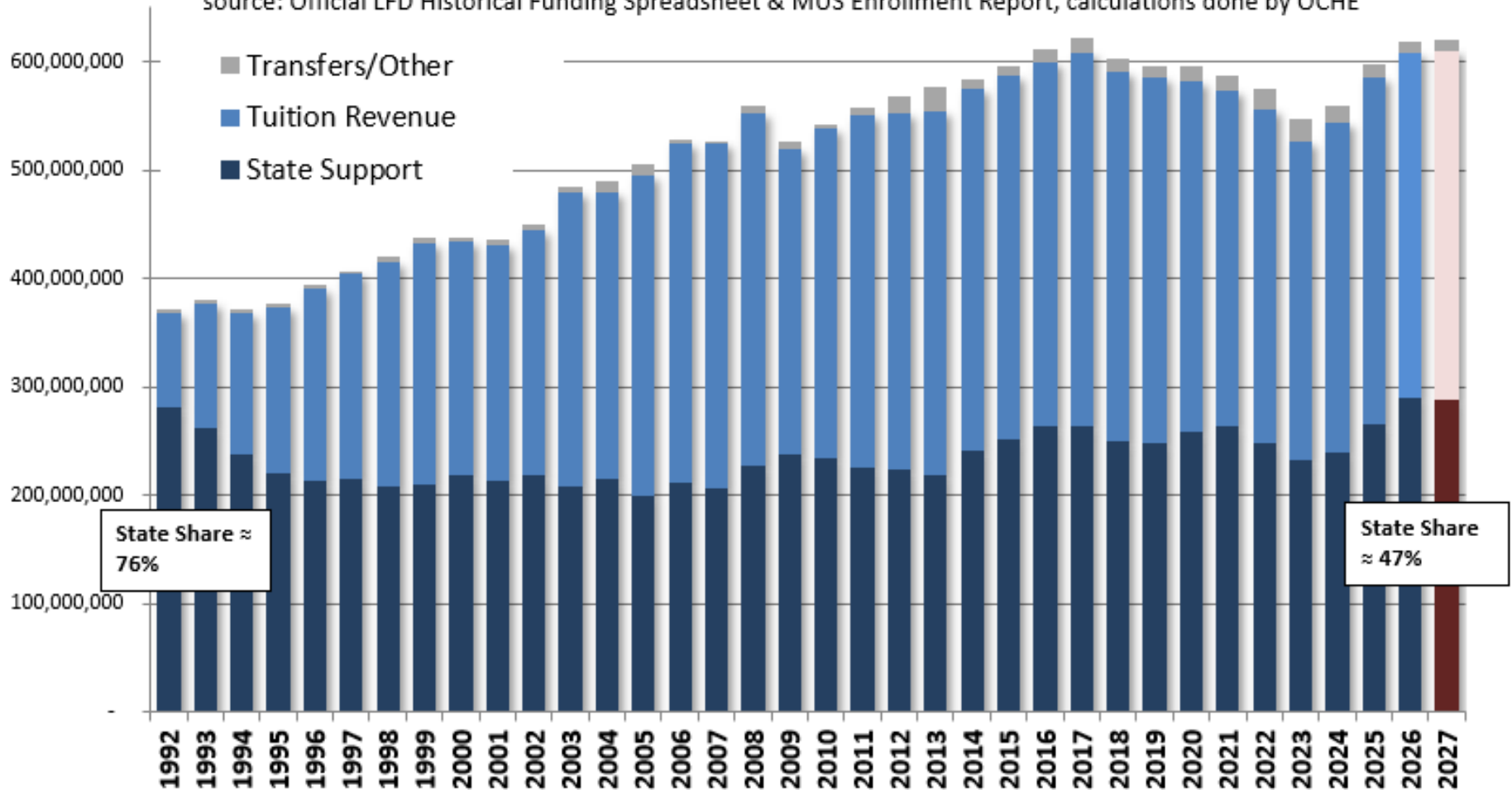

Funding per resident student surpassed the 1992 high mark in 2021

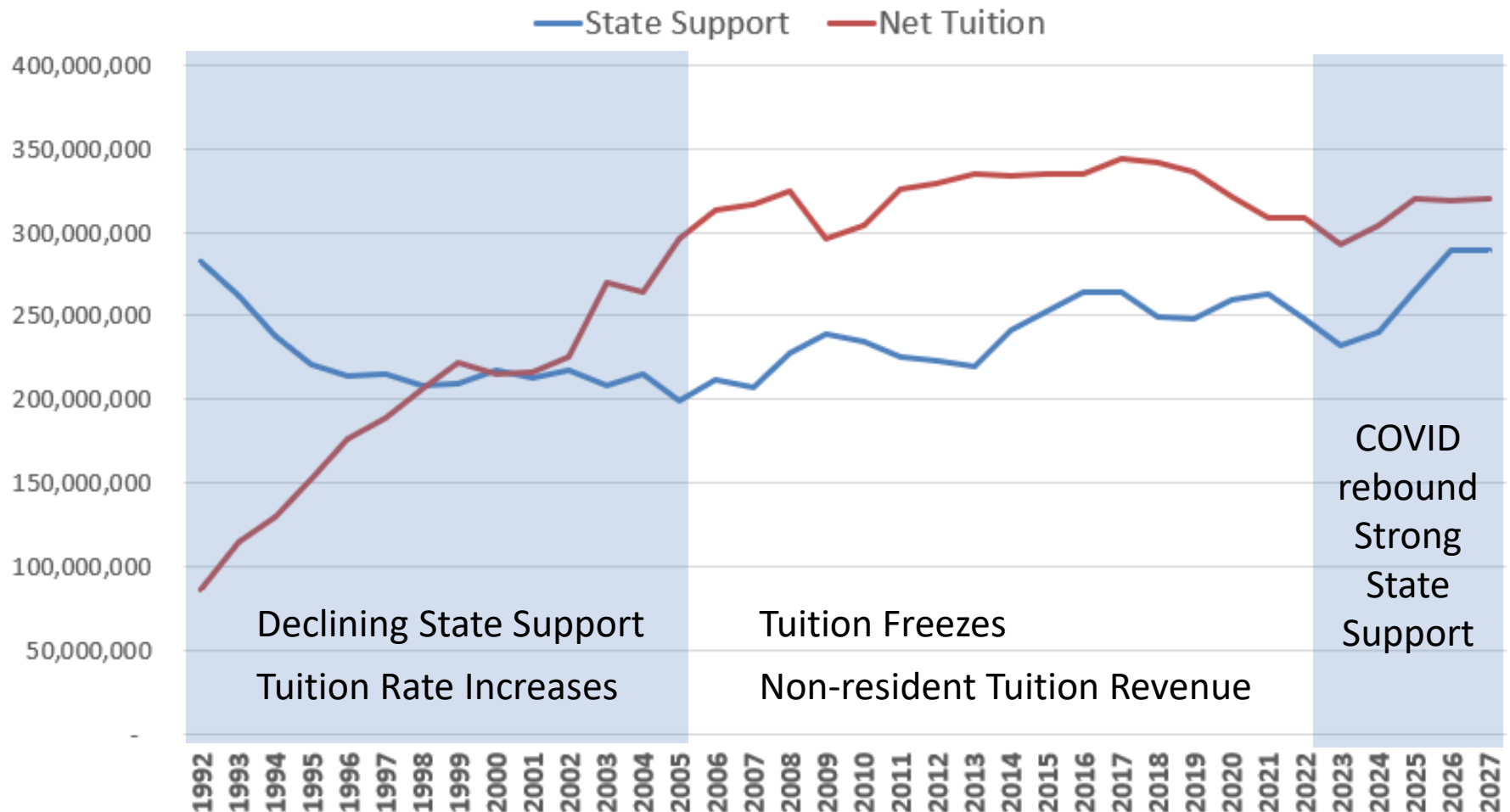

State % Share has dropped from 76% to 47% over the past 30 years

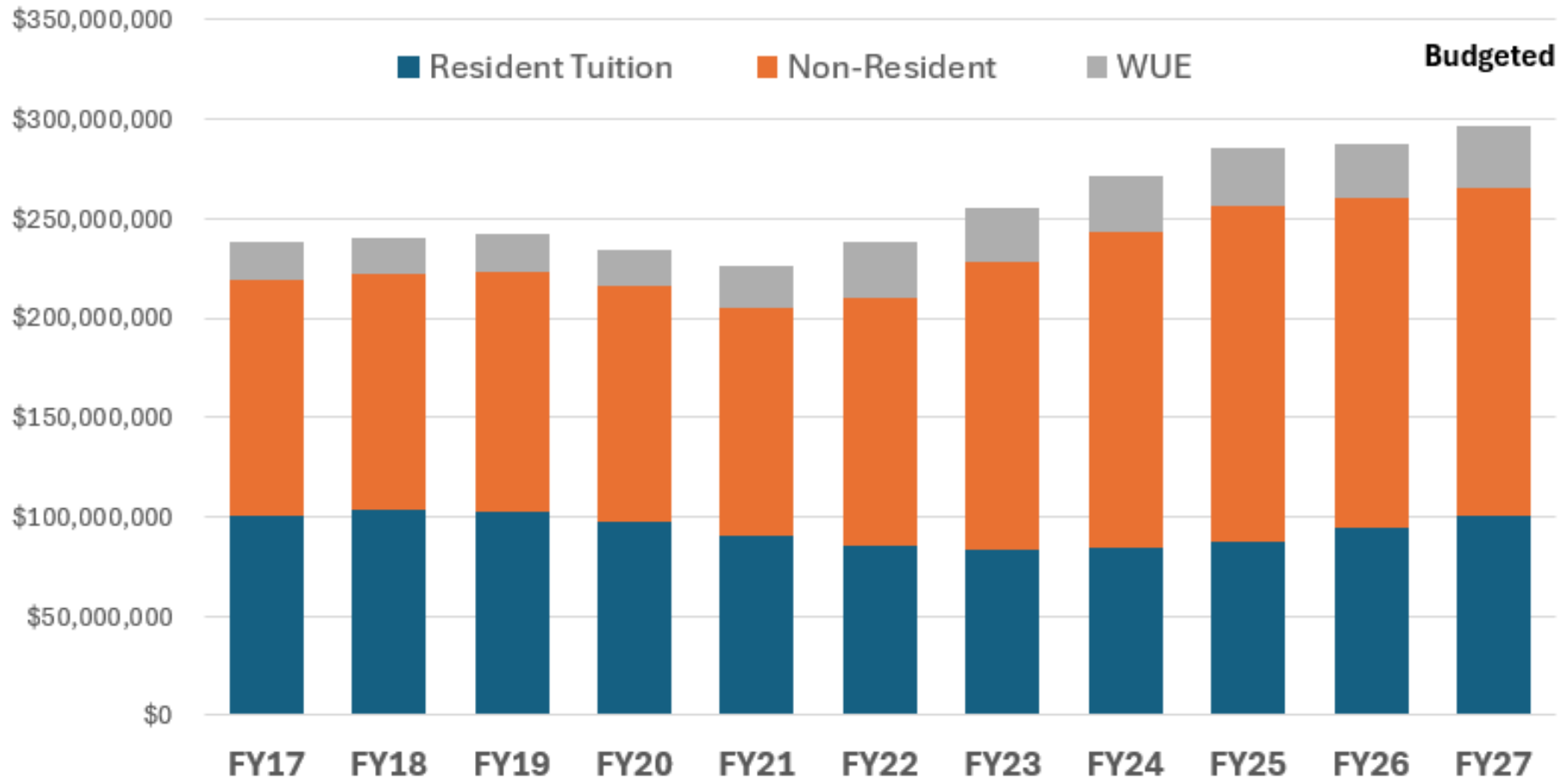
State Support vs. Tuition Revenue Growth (2026 constant dollars)

Net Tuition Revenue

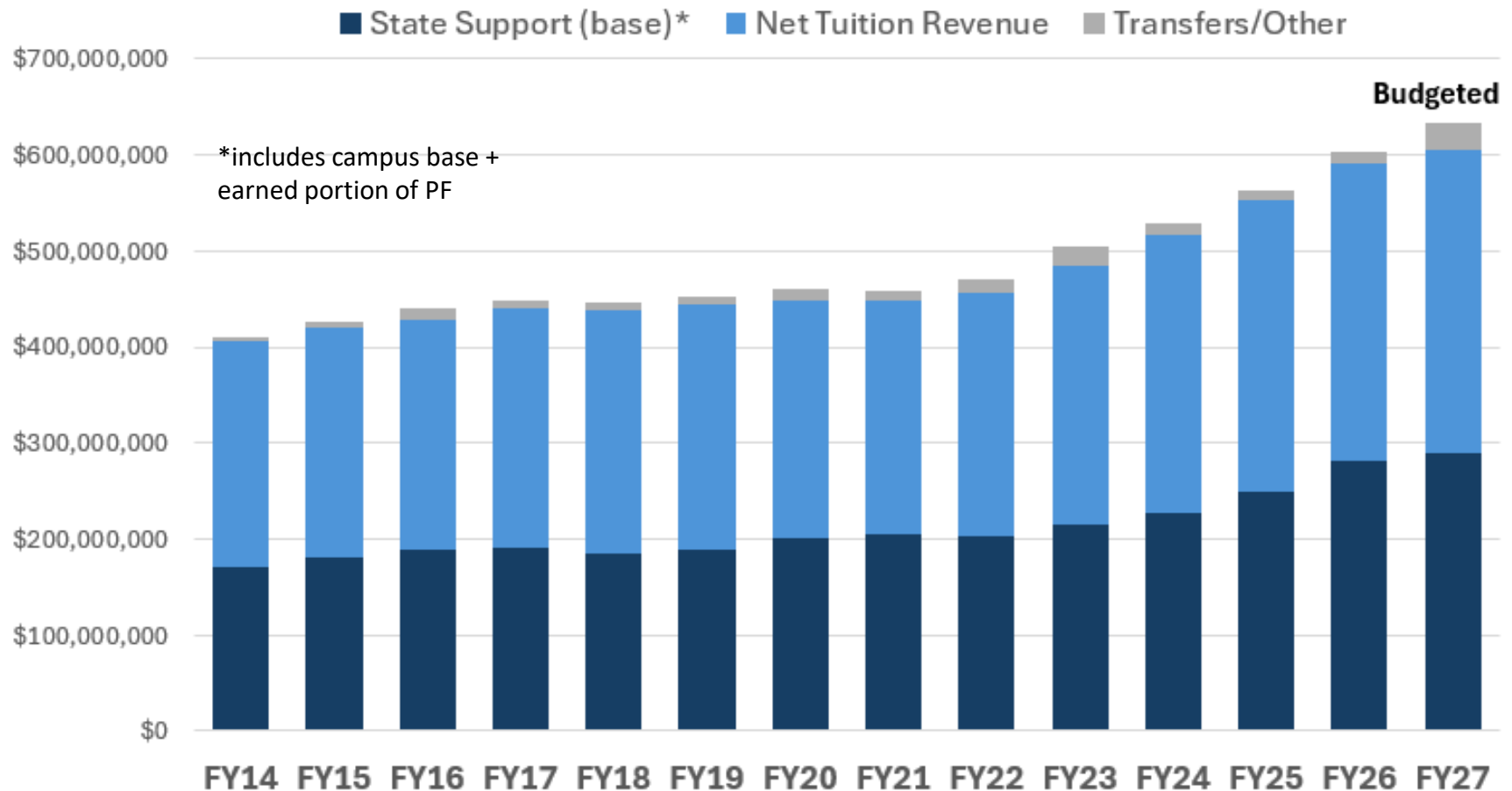

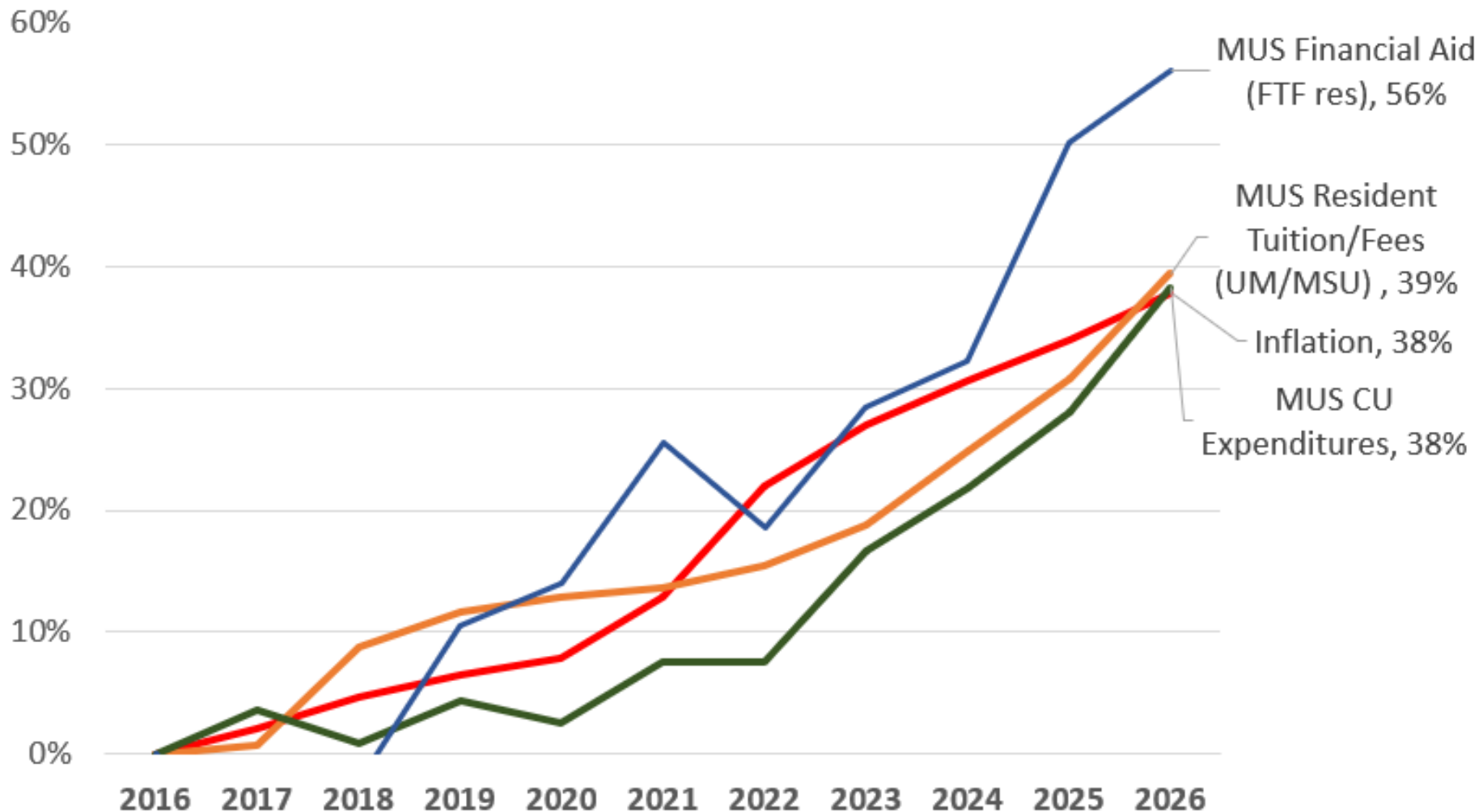


Current Unrestricted Revenue budgeted to increase by \$36M (5%) not including OTO

Growth of Key Budget Drivers

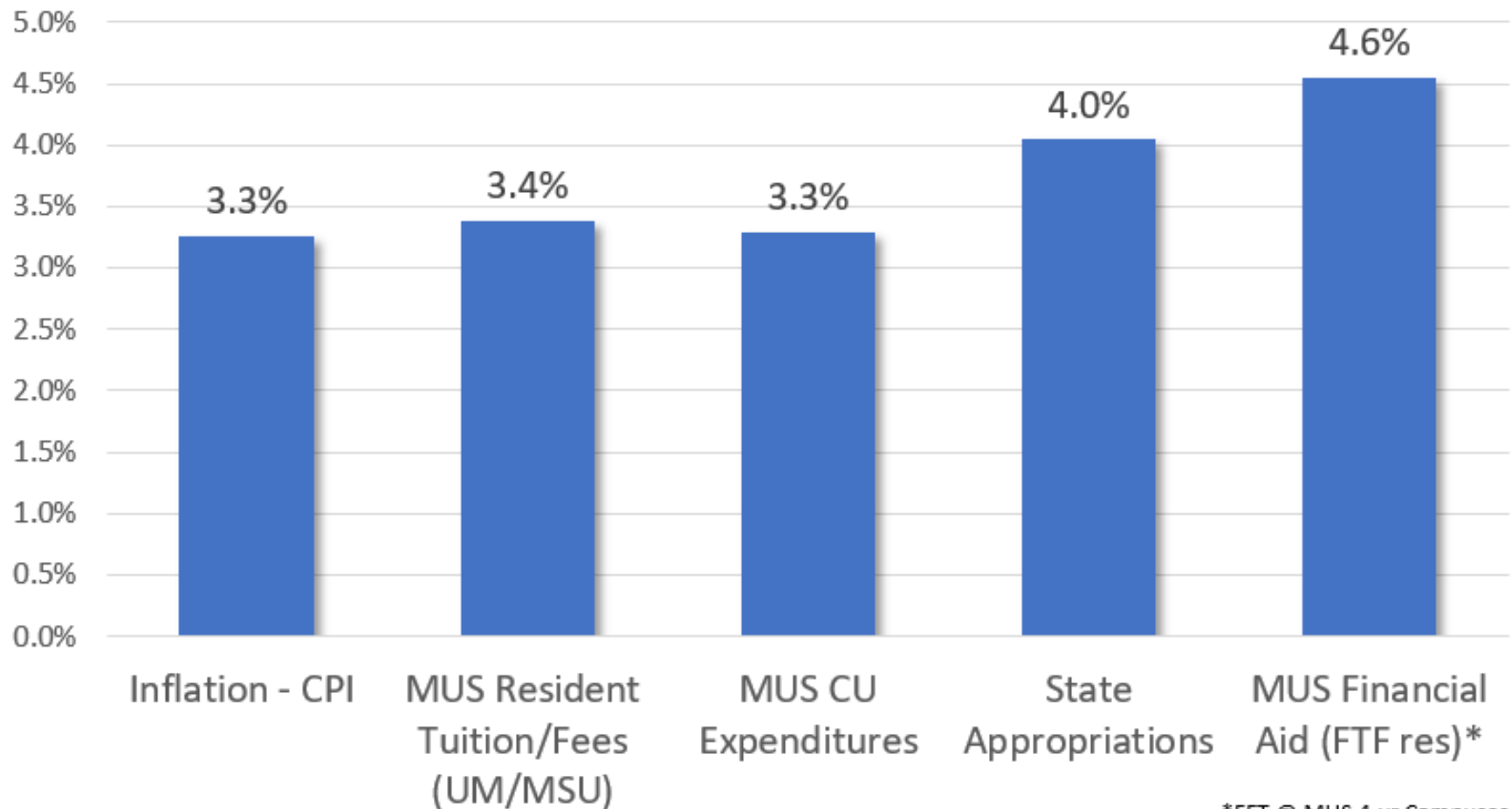
10-year, Cumulative % Change

Compounded Annual Growth Rate, FY16 - FY26

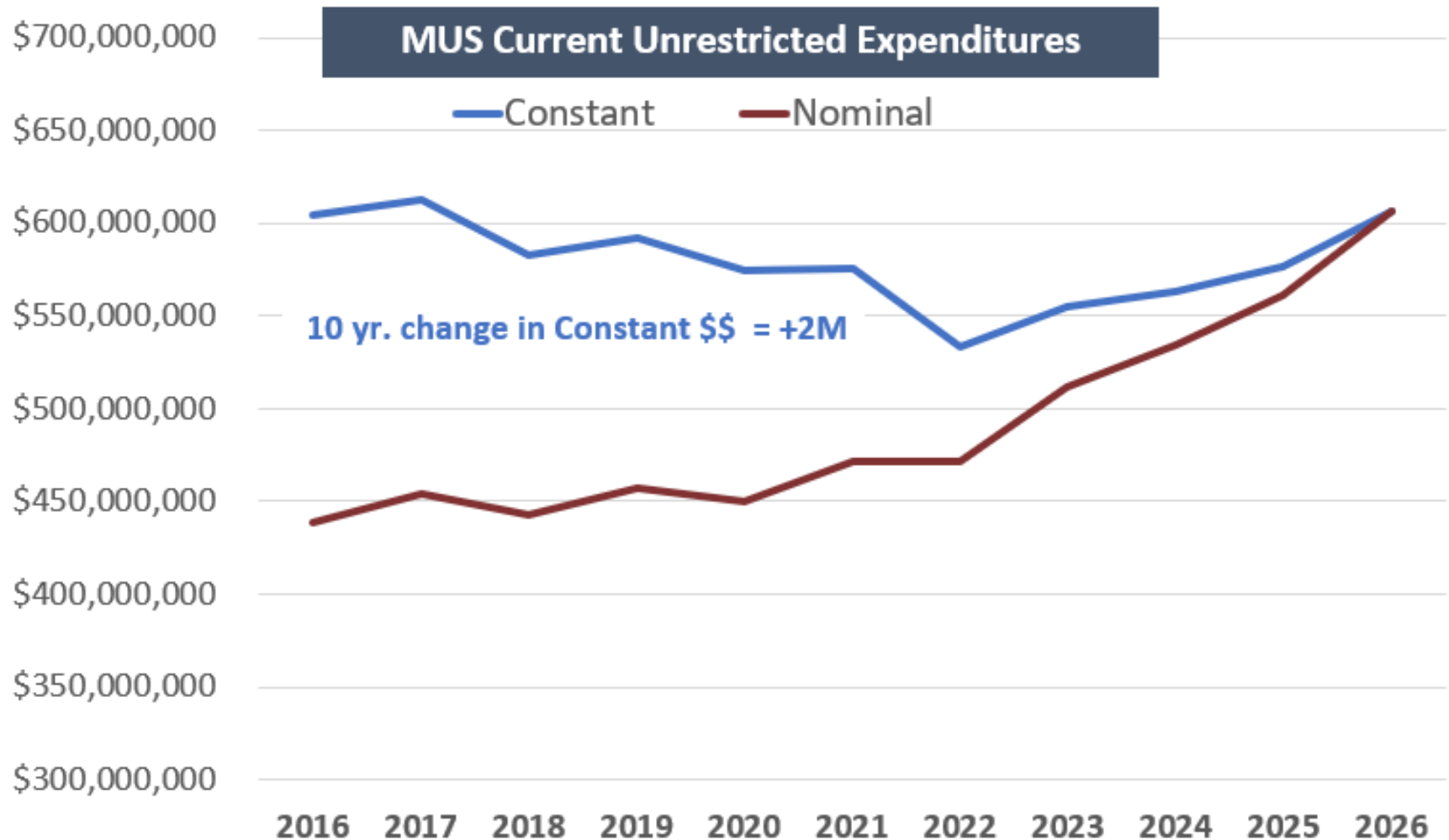

(2026 Constant Dollars)



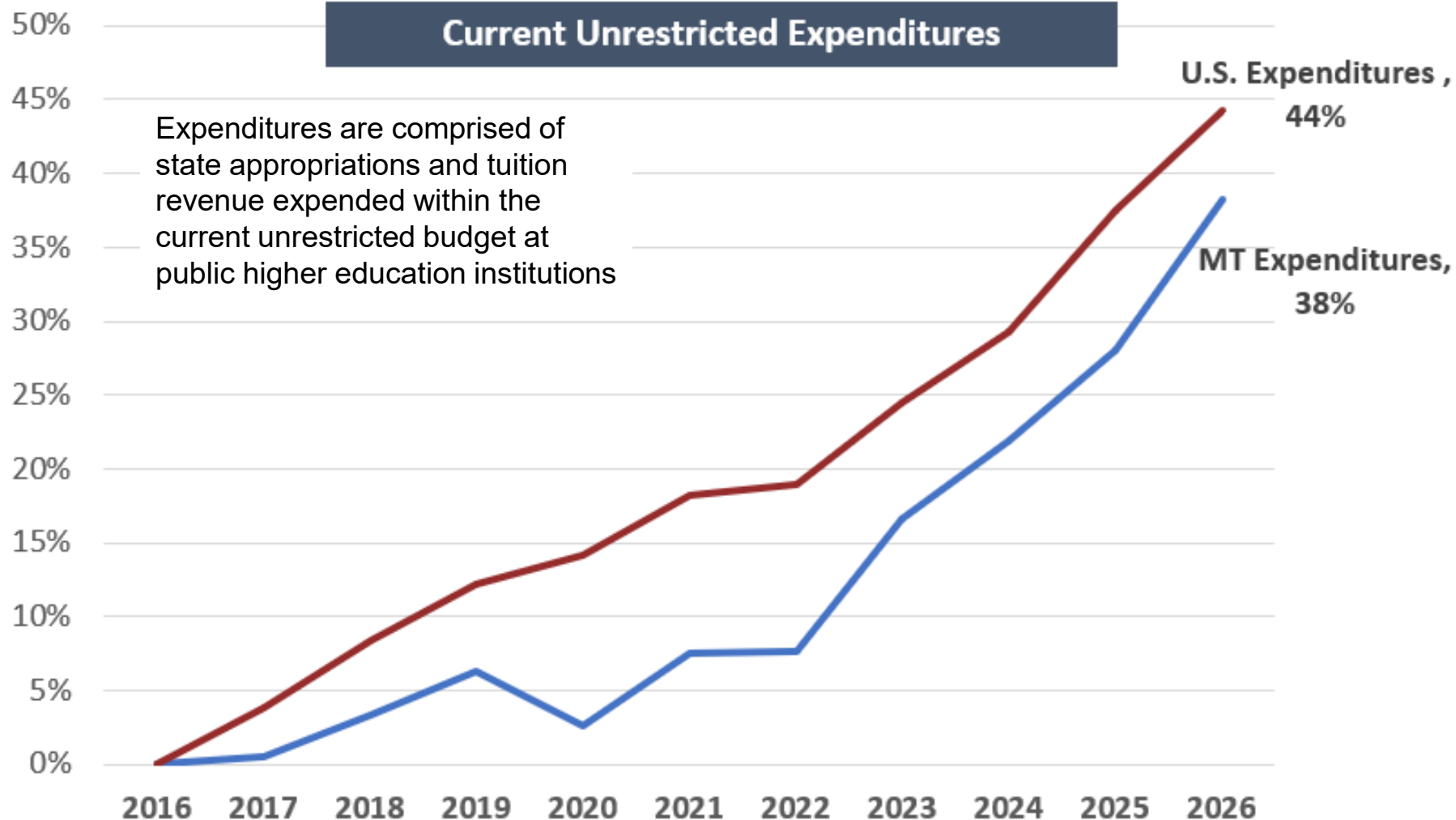
In constant dollars, MUS expenditures increased by \$2M over the past 10 years.

Expenditures are comprised of state appropriations and tuition revenue expended within the current unrestricted budget at public higher education institutions

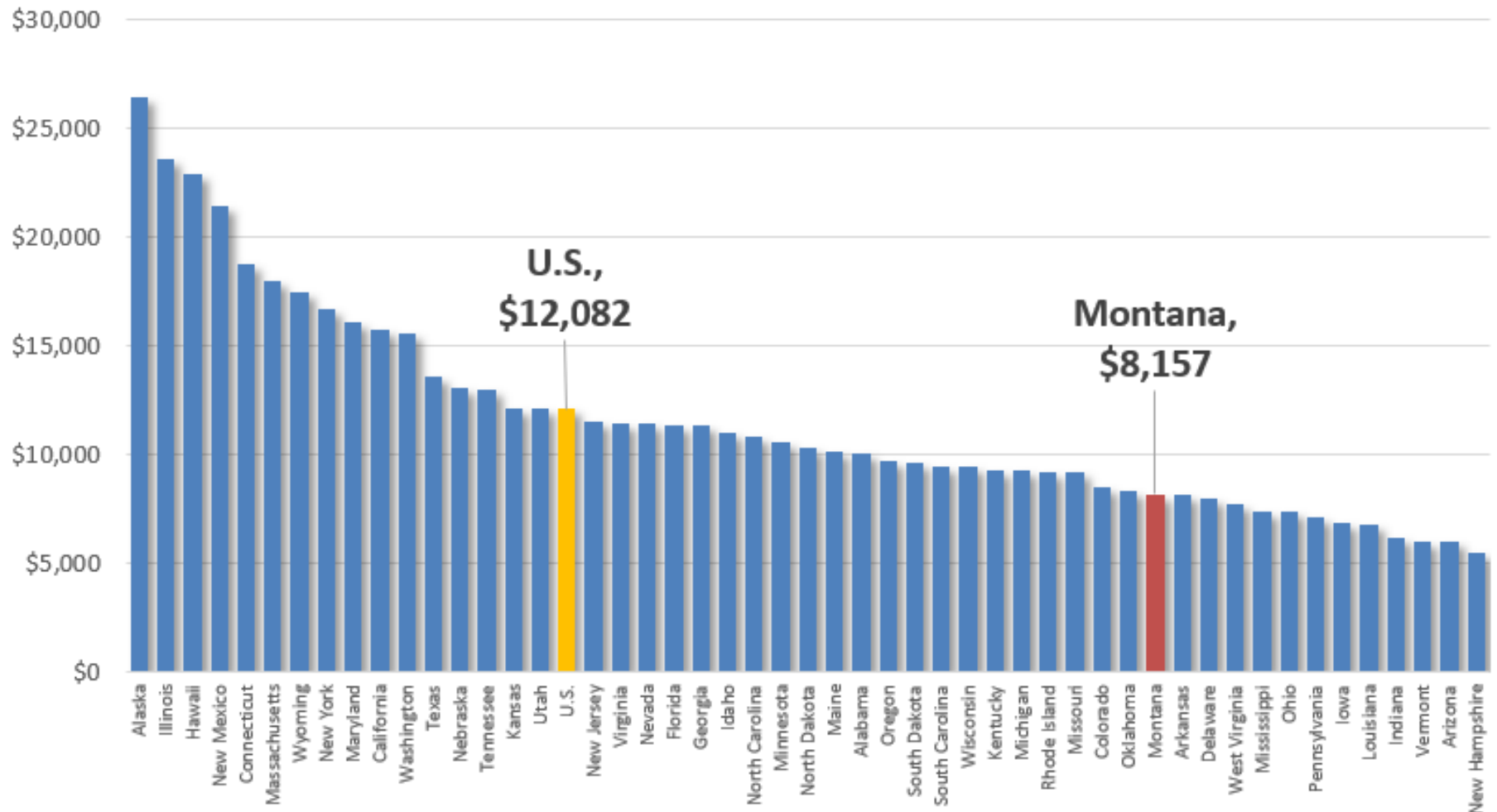


Growth in Higher Ed. expenditures nationwide outpaced increases in the MUS.

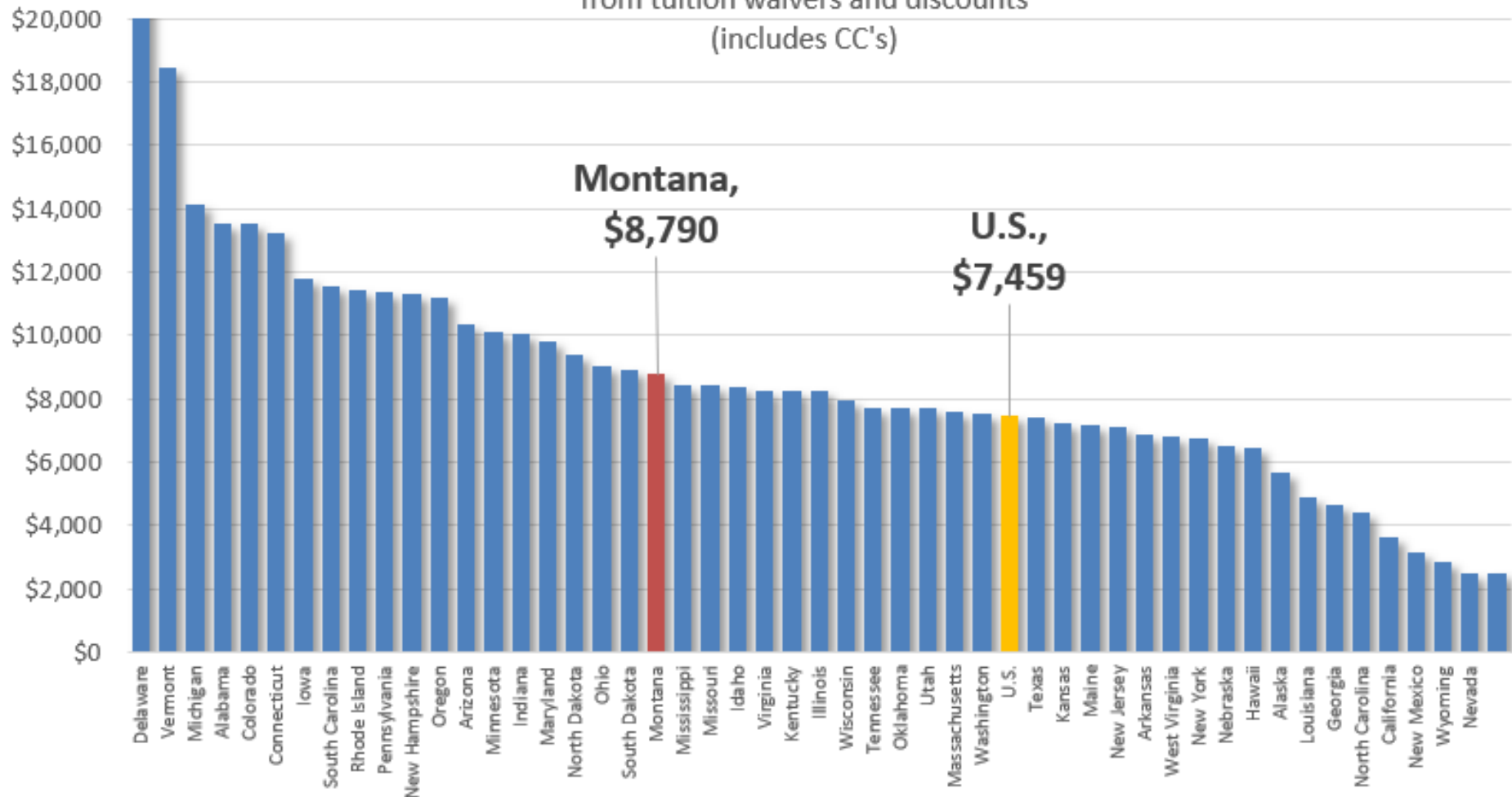

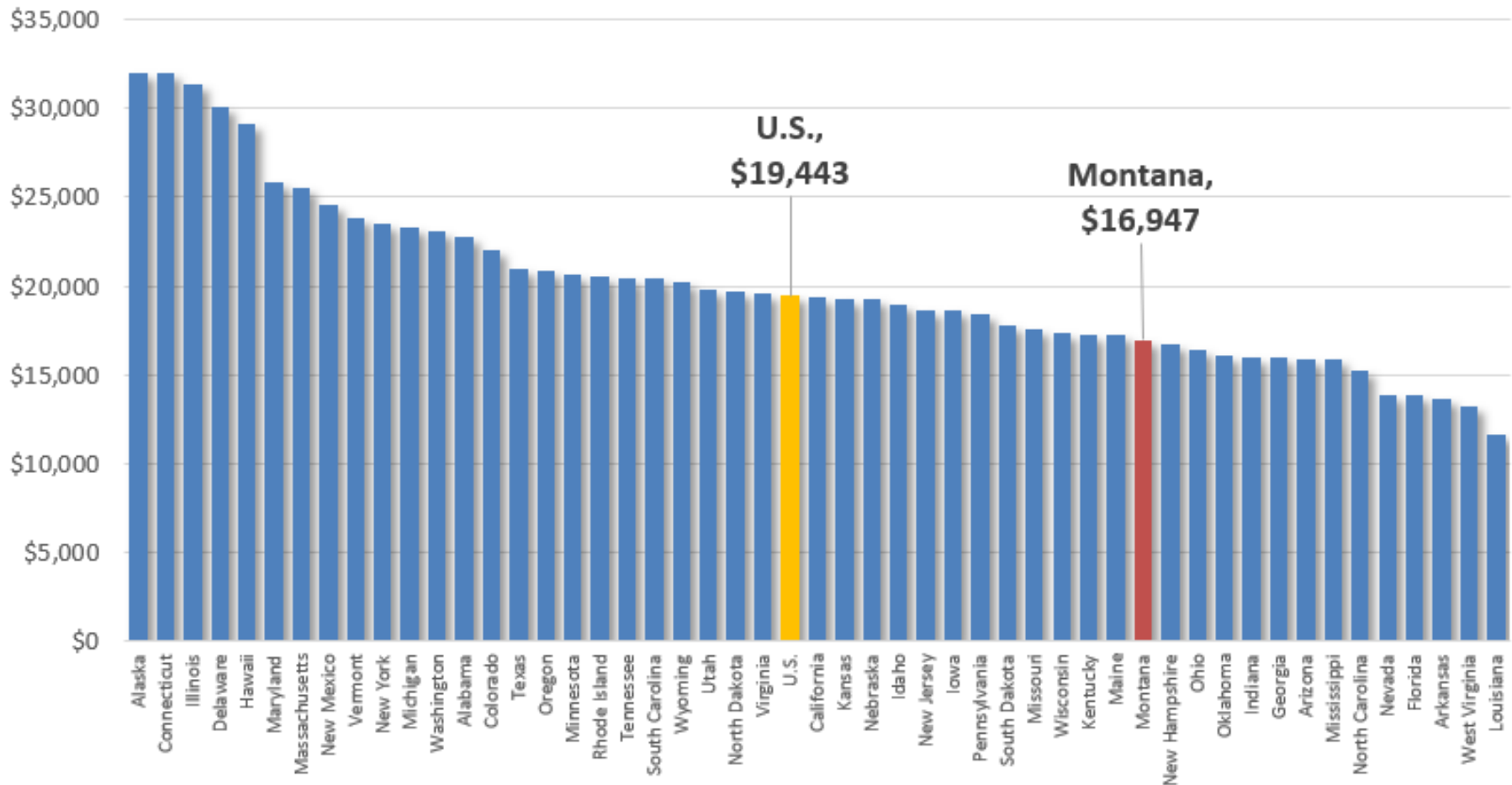

Educational revenue is the sum of public higher education state appropriations and public in-state and out-of-state net tuition. (includes CC's & state funded financial aid)

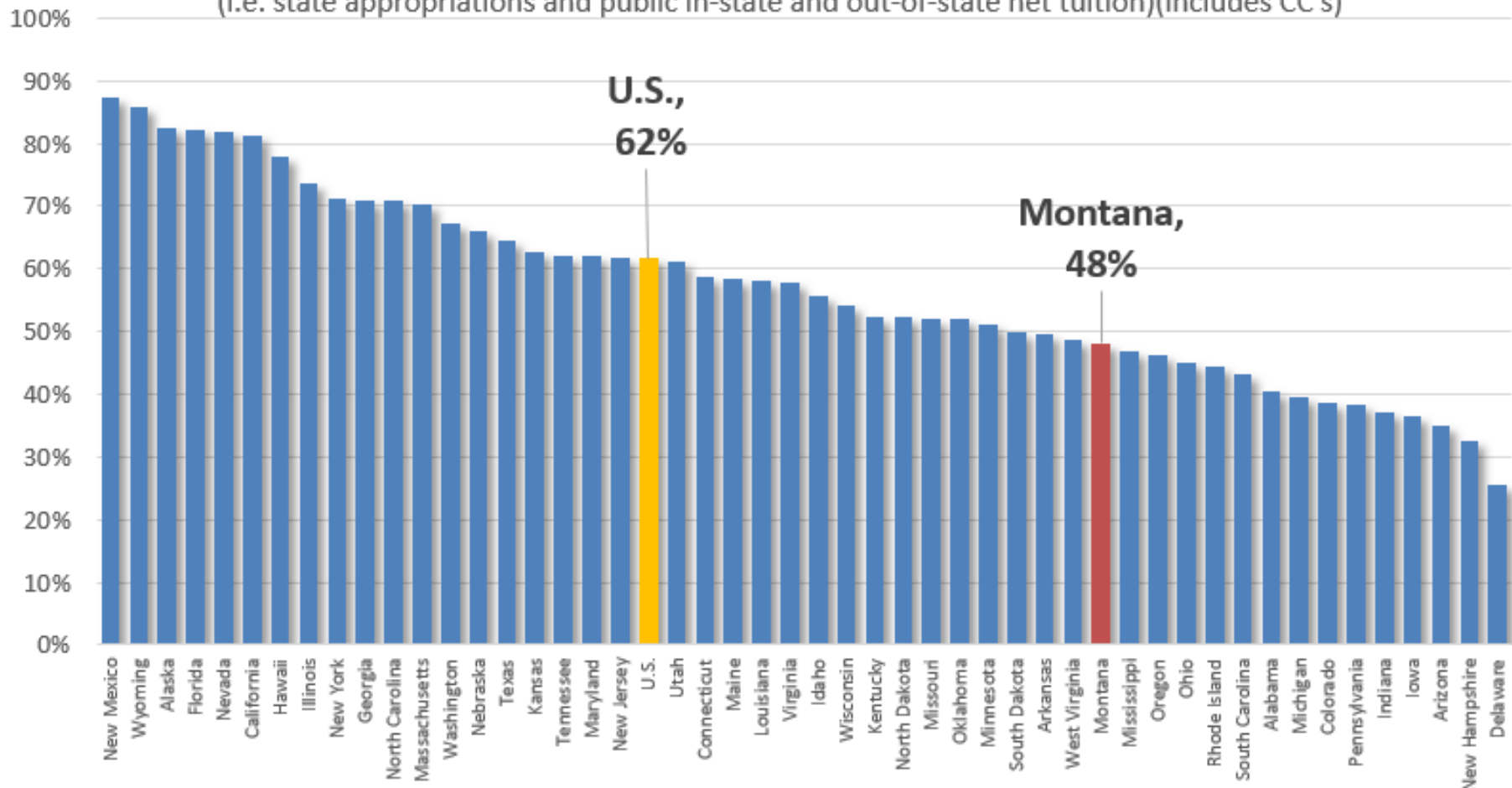

State appropriations as a percent of public higher education total educational revenue (i.e. state appropriations and public in-state and out-of-state net tuition)(includes CC's)

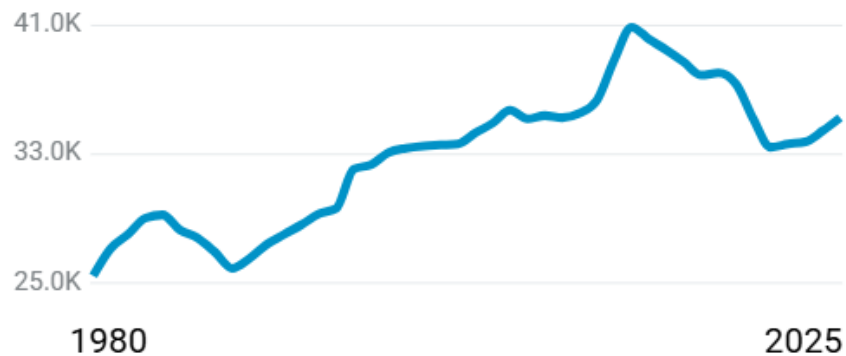

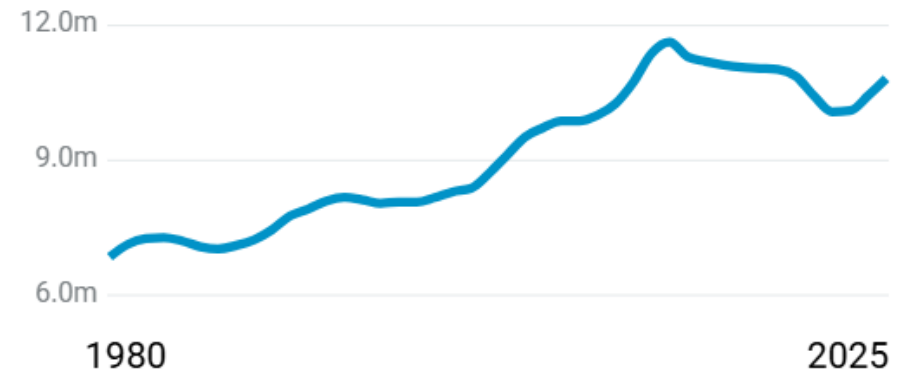

MUS enrollment in FY25 increased by 2.3% (+800 FTE)

National Trends

- Nationally, FY25 enrollment grew by 3.6%, marking third year of gains after 11 straight years of declines following the Great Recession.
- Enrollment increased in 44 states , WY leading the way with 15% increase
- Both 4yr and 2yr institutions saw enrollment increases, with 2yr institutions experiencing higher growth of 5.0% compared to 2.8% among 4yr institutions.
- Despite enrollment increases in 2025, enrollment down 7.2% since high in 2011

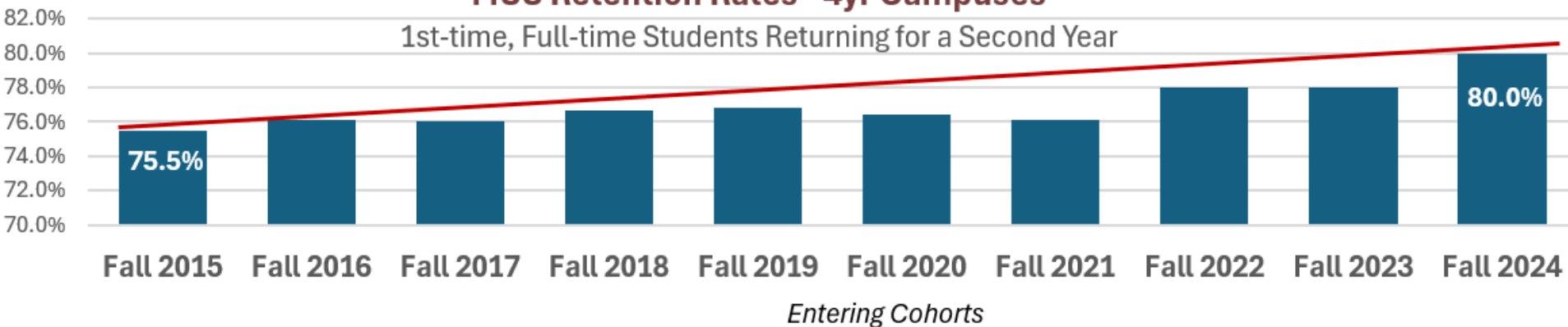

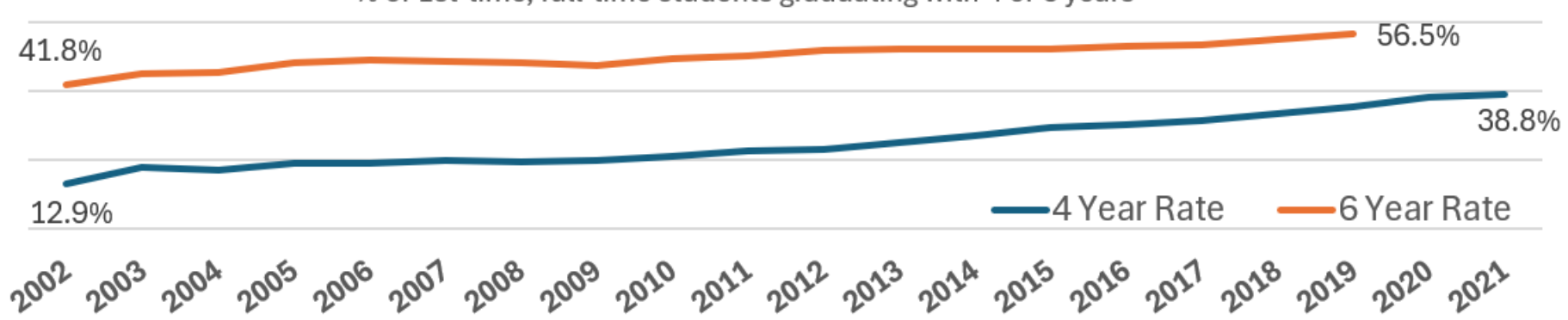
MUS Retention Rates - 4yr Campuses

% of 1st-time, full-time students graduating with 4 or 6 years



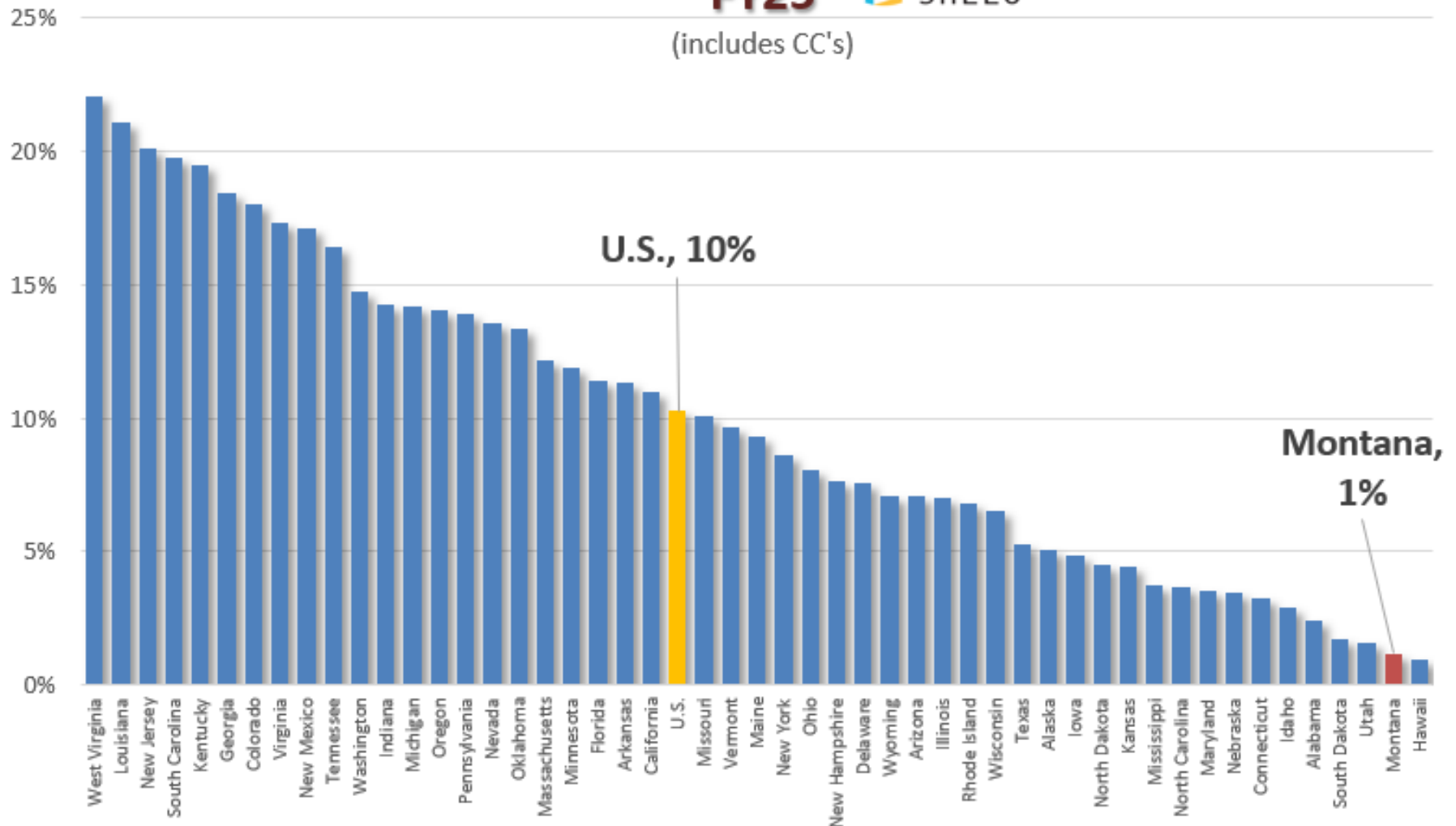

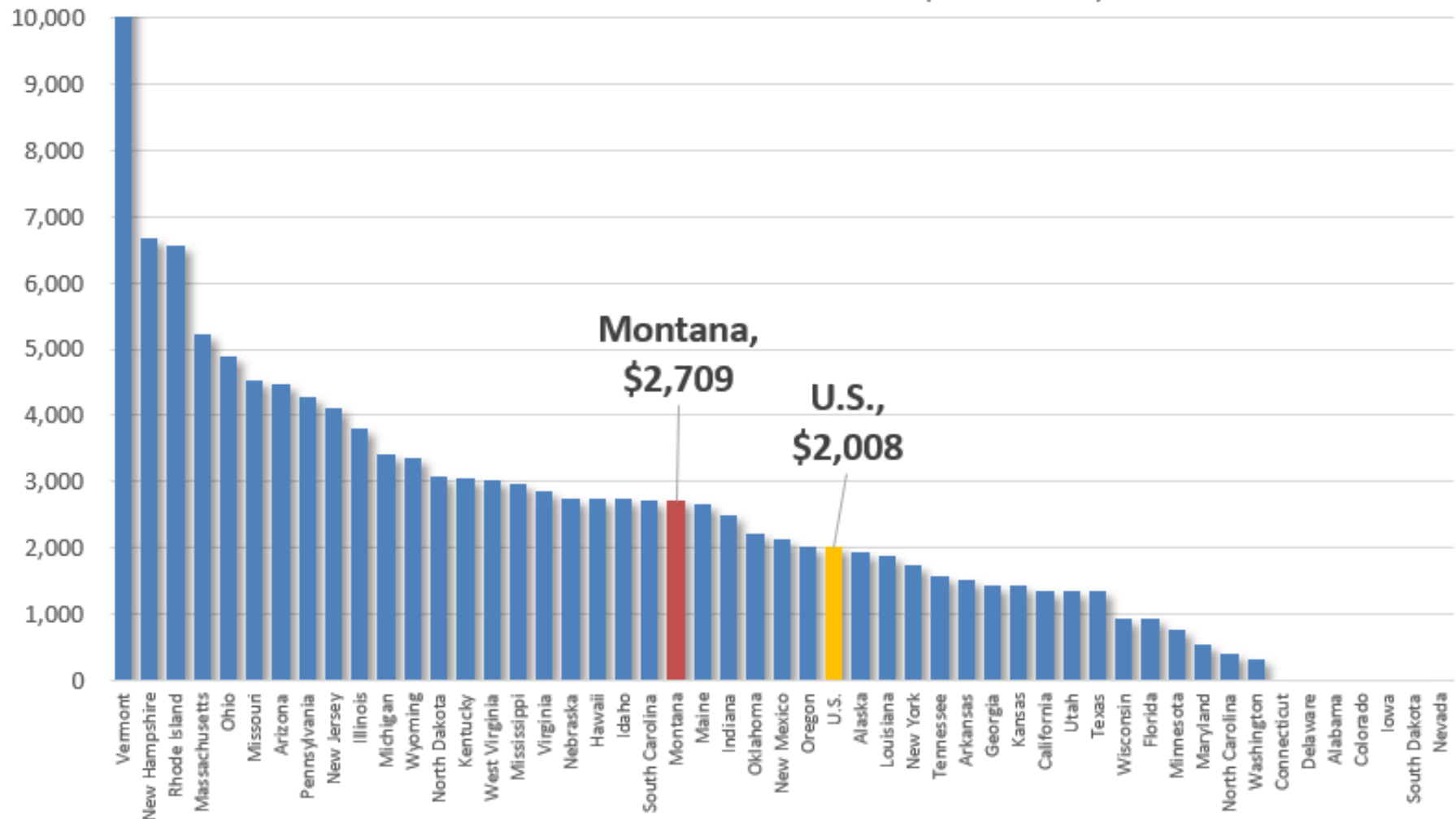

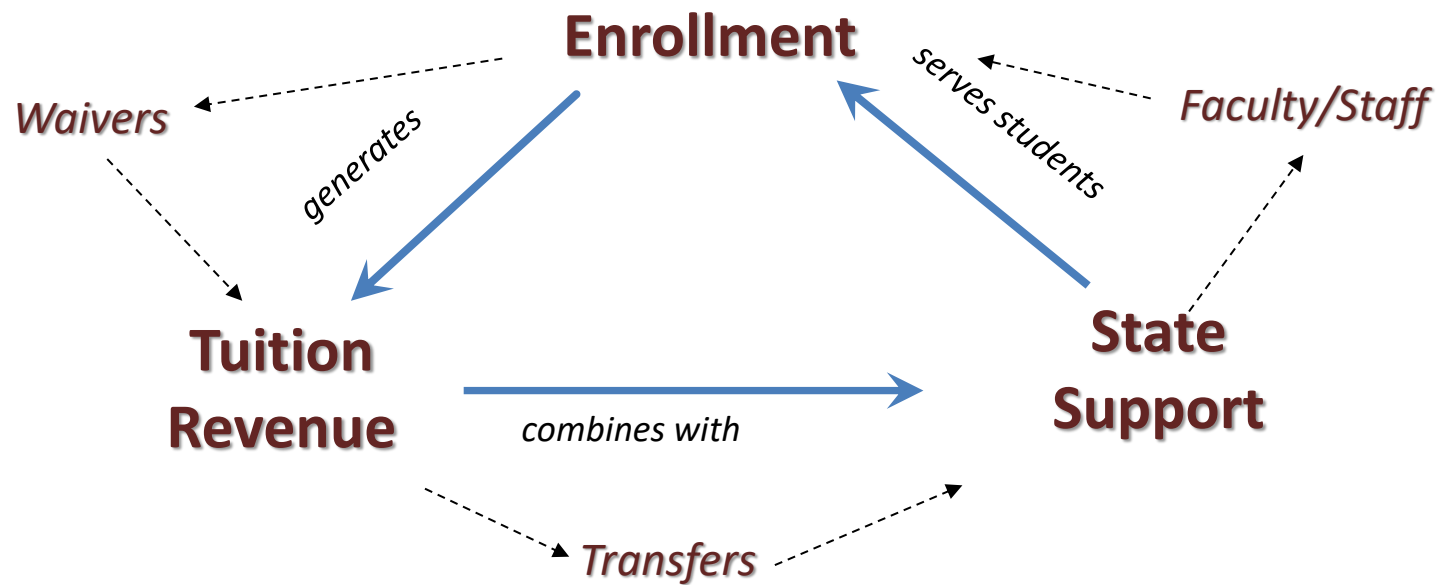
